



4.2 Test Method and test Procedure

The EUT was tested according to ANSI C63.4-2009. The Frequency spectrum From 0.15MHz to 30MHz was investigated. The LISN used was 500hm/50uH as specified by section 5.1 of ANSI C63.4 –2009. Cables and peripherals were moved to find the maximum emission levels for each frequency. Actual Working Voltage and Frequency: 120V~, 60Hz




Block diagram of Test setup
