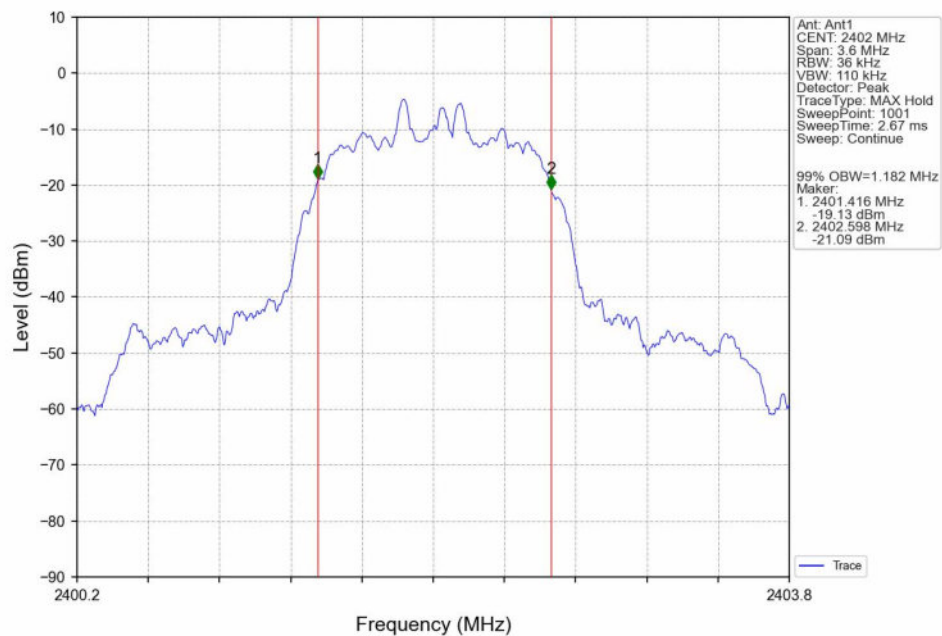

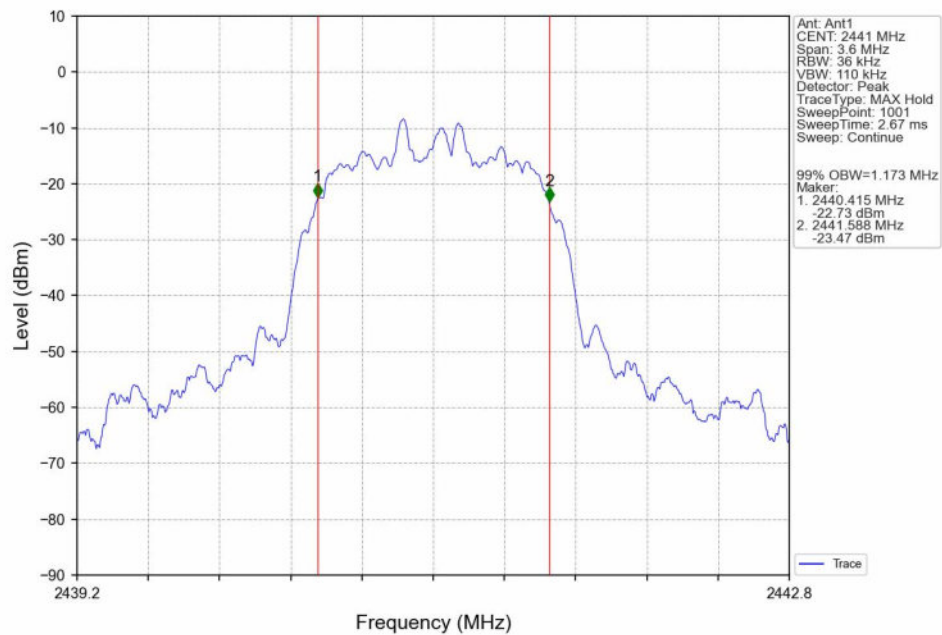


Pi/4DQPSK_2DH5_LCH_2402MHz_Ant1_NTNV

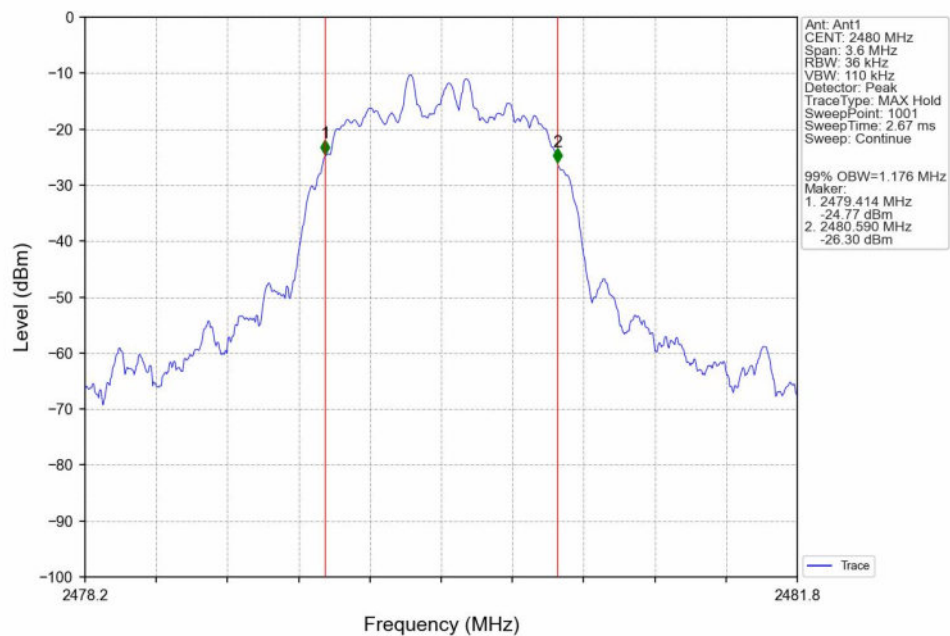

Pi/4DQPSK_2DH5_MCH_2441MHz_Ant1_NTNV

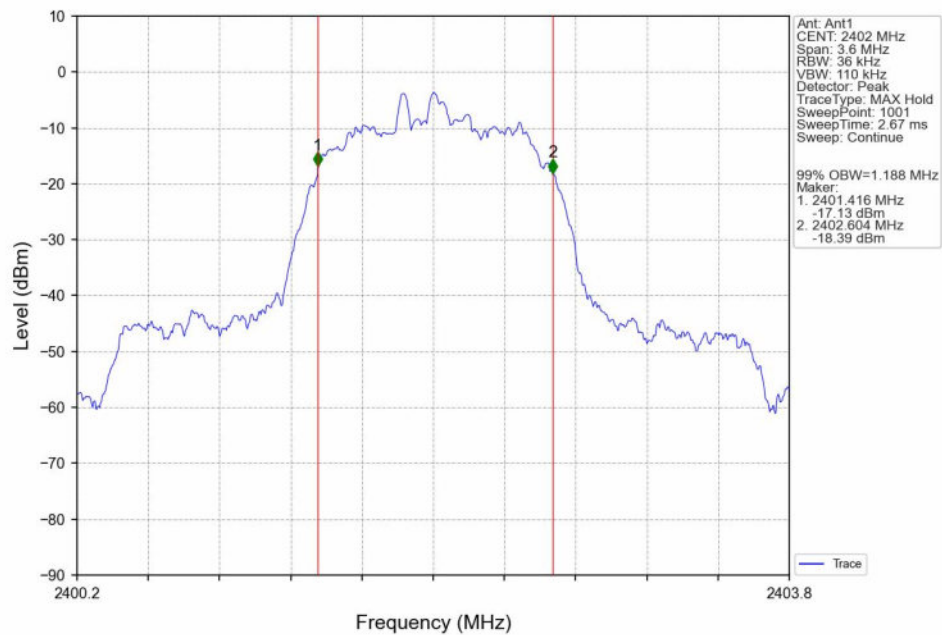


Pi/4DQPSK_2DH5_HCH_2480MHz_Ant1_NTNV

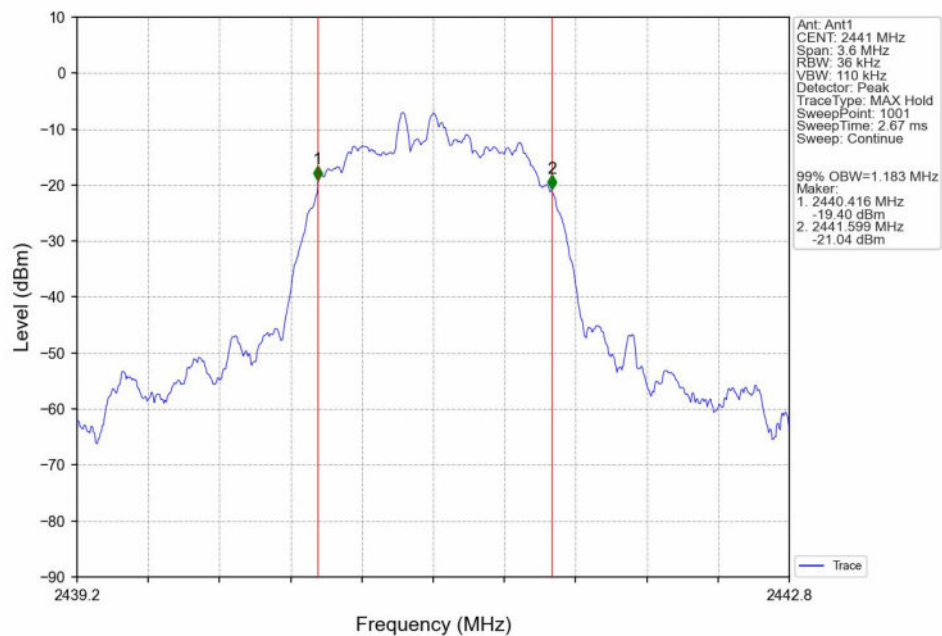

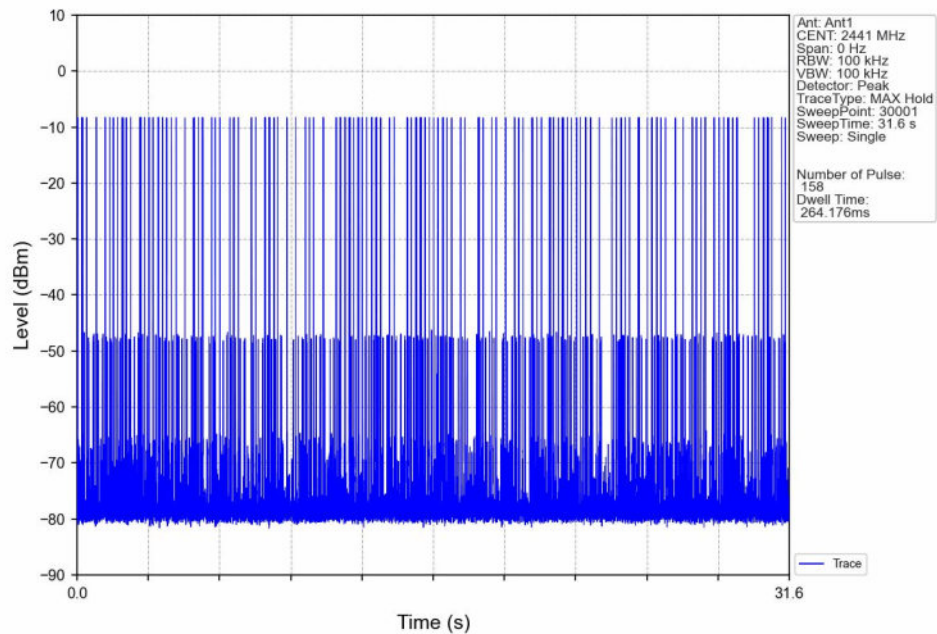

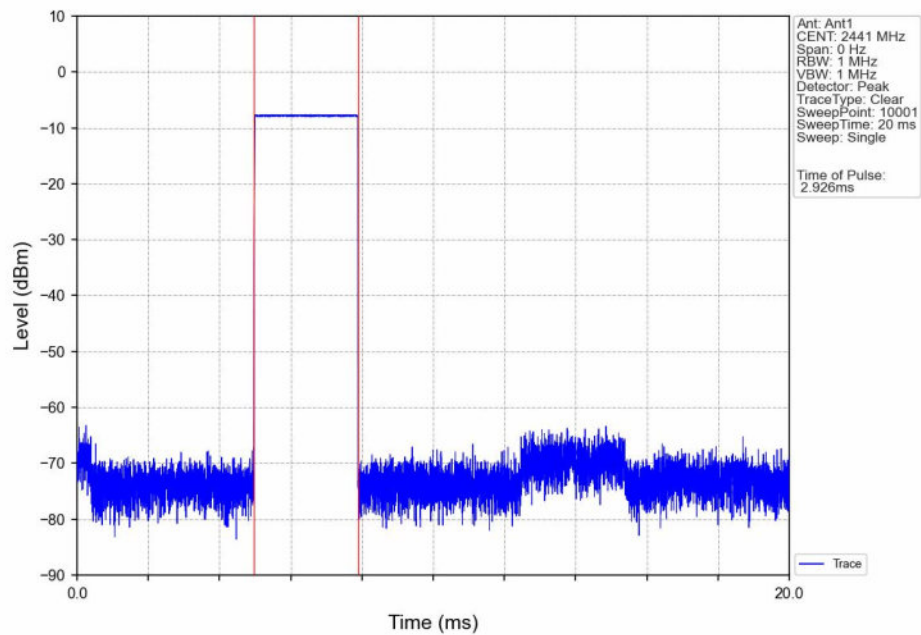

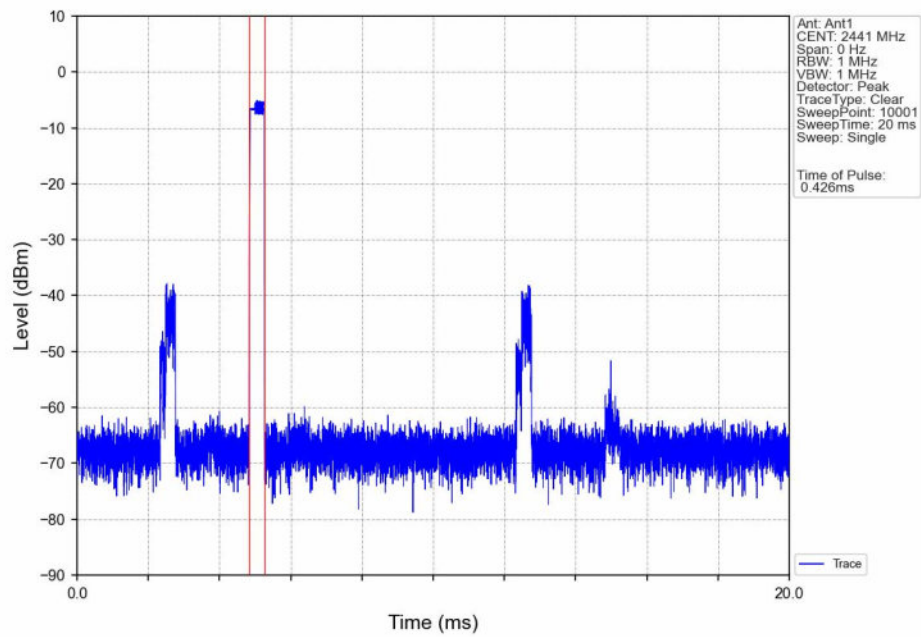

Pi/4DQPSK_2DH1_HOPP_Ant1_NTNV

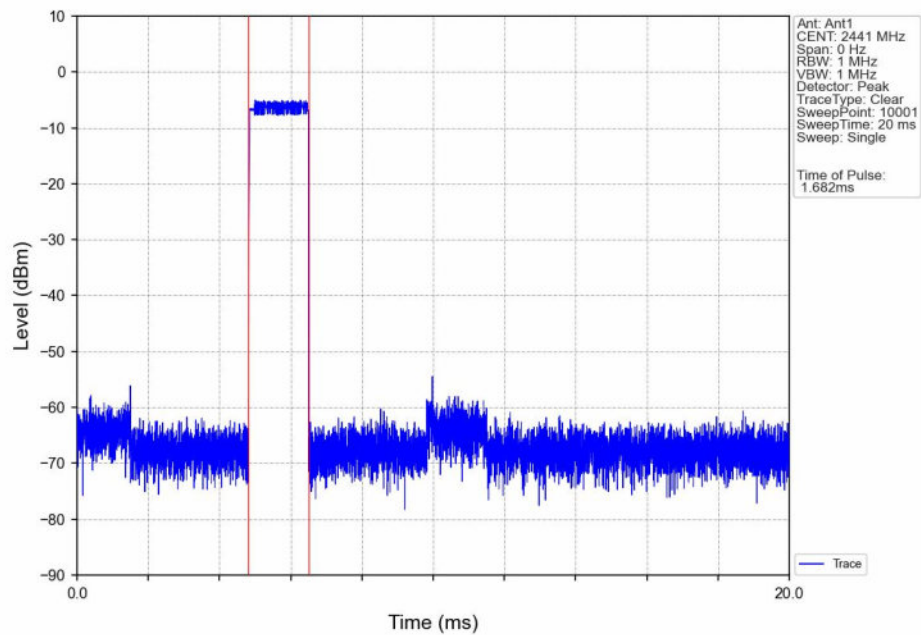

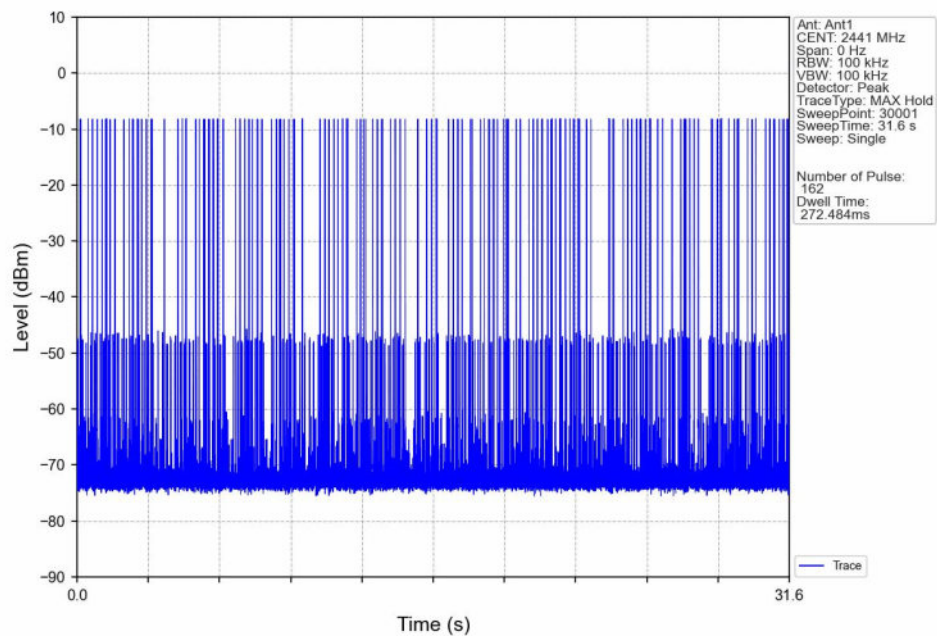

Pi/4DQPSK_2DH3_HOPP_Ant1_NTNV

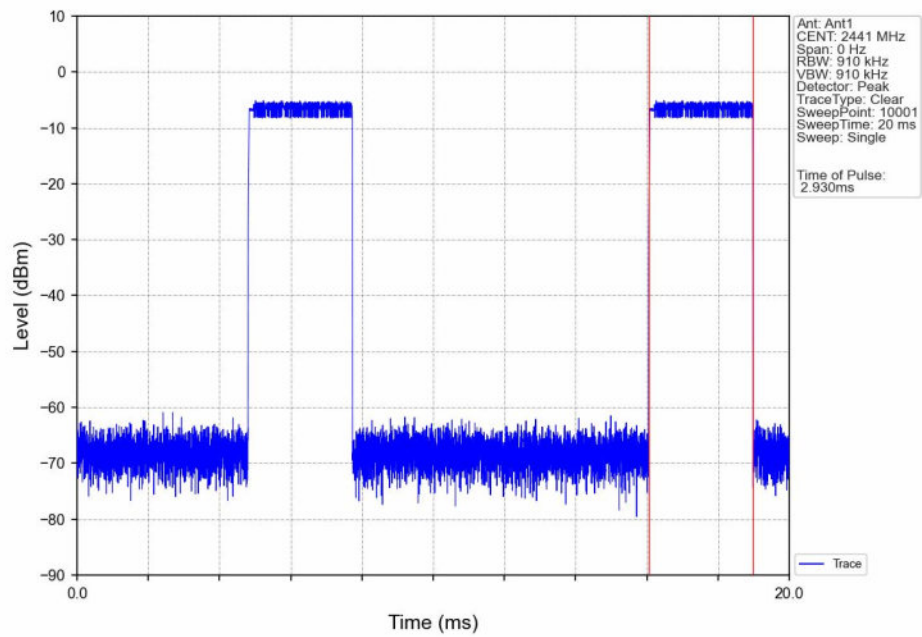
