"limited module," then the module			
manufacturer is responsible for approving the host environment that the limited module is			
used with. The manufacturer of a limited			
module must describe, both in the filing and in			
the installation instructions, the alternative			
means that the limited module manufacturer			
uses to verify that the host meets the necessary			
requirements to satisfy the module limiting			
conditions.			
A limited module manufacturer has the			
flexibility to define its alternative method to			
address the conditions that limit the initial			
approval, such as: shielding, minimum			

signaling amplitude, buffered modulation/data inputs, or power supply regulation. The alternative method could include that the limited module manufacturer reviews detailed test data or host designs prior to giving the host manufacturer approval. This limited module procedure is also applicable for RF exposure evaluation when it is necessary to demonstrate compliance in a specific host. The module manufacturer must state how control of the product into which the modular transmitter will be installed will be maintained such that full compliance of the product is always ensured.
