

## 5 SAR Evaluation

### 5.1 RF Exposure Compliance Requirement

#### 5.1.1 Standard Requirement

According to KDB447498D01 General RF Exposure Guidance v05

##### 4.3.1. Standalone SAR test exclusion considerations

Unless specifically required by the published RF exposure KDB procedures, standalone 1-g head or body and 10-g extremity SAR evaluation for general population exposure conditions, by measurement or numerical simulation, is not required when the corresponding SAR Exclusion Threshold condition, listed below, is satisfied.

#### 5.1.2 Limits

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by:

$$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}] \leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR, where}$$

$f(\text{GHz})$  is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation<sup>17</sup>

The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is  $< 5$  mm, a distance of 5 mm is applied to determine SAR test exclusion

#### 5.1.3 EUT RF Exposure

##### For Classic mode

The Max Conducted Peak Output Power is 2.95dBm in Highest channel(2.480 GHz);

The best case gain of the antenna is 0dBi

$$\text{EIRP} = 2.95\text{dBm} + 0\text{dBi} = 2.95\text{dBm}$$

2.95dBm logarithmic terms convert to numeric result is nearly 1.9724 mW

According to the formula. calculate the EIRP test result:

$$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}]$$

$$\text{General RF Exposure} = (1.9724 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.480 \text{ GHz}} = 0.6212 \text{ } \textcircled{1}$$

SAR requirement:

$$S = 3.0 \text{ } \textcircled{2} ;$$

$$\textcircled{1} < \textcircled{2}.$$

So the SAR report is not required.

**For BLE mode**

The Max Conducted Peak Output Power is 2.46dBm in Highest channel(2.480 GHz);

The best case gain of the antenna is 0dBi

EIRP= 2.46dBm + 0dBi = 2.46dBm

2.46dBm logarithmic terms convert to numeric result is nearly 1.7620 mW

According to the formula. calculate the EIRP test result:

$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}]$

General RF Exposure =  $(1.7620 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.480 \text{ GHz}} = 0.5550$  ①

SAR requirement:

$S = 3.0$  ② ;

So the SAR report is not required.
