2. TEST METHODOLOGY

All calculations were made in accordance with FCC OET Bulletin 65 Edition 97-01 and IC Safety Code 6.

3. REFERENCES

All measurements were made as documented in test report UL LLC Report R10015049-RF for operation 2.4 GHz band.

Output power, Duty cycle and Antenna gain data is excerpted from the applicable test reports.

Antenna gain data is excerpted from product documentation provided by the applicant.

4. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 12 Laboratory Dr., Research Triangle Park, NC 27709, USA.

UL LLC (RTP) is accredited by NVLAP, Laboratory Code 200246-0. The full scope of accreditation can be viewed at http://ts.nist.gov/standards/scopes/2002460.htm.

5. DESCRIPTION OF EUT

The Wall Switch, p/n CWD-CWC-WH and CWS-CWC-WH is a 2.4 GHz DSSS transceiver used with light fixtures. The Wall Switch contains an O-QPSK modulation and a 250 kbps data rate. The Wall Switch receives signals from other devices to control the fixture.

The radio module is manufactured by Cree Inc.

Part Number CWD-CWC-WH was the unit tested. Part Number CWD-CWC-WH is the same as CWS-CWC-WH except CWS-CWC-WH is a depopulated version of the tested version. CWD-CWC-WH has added dimming functions and circuitry that p/n CWS-CWC-WH does not.

NOTE 1 TO TABLE 1: Occupational/controlled limits apply in situations in which persons are exposed as a consequence of their employment provided those persons are fully aware of the potential for exposure and can exercise control over their exposure. Limits for occupational/controlled exposure also apply in situations when an individual is transient through a location where occupational/controlled limits apply provided he or she is made aware of the potential for exposure.

6.2. IC RULES

IC Safety Code 6, Section 2.2.1 (a) A person other than an RF and microwave exposed worker shall not be exposed to electromagnetic radiation in a frequency band listed in Column 1 of Table 5, if the field strength exceeds the value given in Column 2 or 3 of Table 5, when averaged spatially and over time, or if the power density exceeds the value given in Column 4 of Table 5, when averaged spatially and over time.

6.3. EQUATIONS

POWER DENSITY

Power density is given by:

 $S = EIRP / (4 * Pi * D^2)$

Where

S = Power density in mW/cm^2 EIRP = Equivalent Isotropic Radiated Power in mW D = Separation distance in cm

Power density in units of mW/cm² is converted to units of W/m² by multiplying by 10.

DISTANCE

Distance is given by:

D = SQRT (EIRP / (4 * Pi * S))

Where

D = Separation distance in cm EIRP = Equivalent Isotropic Radiated Power in mW S = Power density in mW/cm^2

SOURCE-BASED DUTY CYCLE

Where applicable (for example, multi-slot cell phone applications) a duty cycle factor may be applied.

Source-based time-averaged EIRP = (DC / 100) * EIRP

Where

DC = Duty Cycle in %, as applicable EIRP = Equivalent Isotropic Radiated Power in W DATE: 2014-07-15

MIMO AND COLOCATED TRANSMITTERS (IDENTICAL LIMIT FOR ALL TRANSMITTERS)

For multiple chain devices, and colocated transmitters operating simultaneously in frequency bands where the limit is identical, the total power density is calculated using the total EIRP obtained by summing the EIRP (in linear units) of each transmitter.

Total EIRP = (EIRP1) + (EIRP2) + ... + (EIRPn)

where

EIRPx = Source-based time-averaged EIRP of chain x or transmitter x

The total EIRP is then used to calculate the Power Density or the Distance as applicable.

MIMO AND COLOCATED TRANSMITTERS

For multiple colocated transmitters operating simultaneously in frequency bands where different limits apply:

The Power Density at the specified separation distance is calculated for each transmitter chain or transmitter.

The fraction of the exposure limit is calculated for each chain or transmitter as (Power Density of chain or transmitter) / (Limit applicable to that chain or transmitter).

The fractions are summed.

Compliance is established if the sum of the fractions is less than or equal to one.

6.4. LIMITS AND IC EXEMPTION

VARIABLE LIMITS

For mobile radio equipment operating in the cellular phone band, the lowest power density limit is calculated using the lowest frequency:

824 MHz / 1500 = 0.55 mW/cm² (FCC) 824 MHz / 150 = 5.5 W/m² (IC).

FIXED LIMITS

For operation in the PCS band, the 2.4 GHz band and the 5 GHz bands:

From FCC §1.1310 Table 1 (B), the maximum value of $S = 1.0 \text{ mW/cm}^2$ From IC Safety Code 6, Section 2.2 Table 5 Column 4, $S = 10 \text{ W/m}^2$

INDUSTRY CANADA EXEMPTION

RSS-102 Clause 2.5.2 RF exposure evaluation is required if the separation distance between the user and the device's radiating element is greater than 20 cm, except when the device operates as follows:

•below 1.5 GHz and the maximum e.i.r.p. of the device is equal to or less than 2.5 W;

•at or above 1.5 GHz and the maximum e.i.r.p. of the device is equal to or less than 5 W.

7. RF EXPOSURE RESULTS

In the table(s) below, Power and Gain are entered in units of dBm and dBi respectively and conversions to linear forms are used for the calculations.

Note, the following device is not considered a head and body device. The device is considered an extremities device.

According to KDB 447498 D01 General RF Exposure Guidance v05, section 4.3.1 At 100 MHz to 6 GHz and for test separation distances ≤ 50 mm, the SAR test exclusion threshold is determined according to the following;

- a) [(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)] $x [\sqrt{f(GHz)}] \le 3.0$
- SAR test exclusion threshold

Frequency : 2480 MHz (min. separation distances = 5 mm) SAR test exclusion thresholds (5 mm) = $[(4/5) * \sqrt{2.480}] = 1.26 \le 3.0$.

Note 1: For distances < 5mm, a distance of 5mm is used to determine SAR exclusion. For distances < 50mm the calculation must yield a value <= 3.0 to exlcude that position from body or head SAR and <=7.5 for Extremities

Note 2: Output power is the maximum rated power (including tune-up or manufacturing tolerances) and includes source-based averaging.

Note 3: If the antenna separation distance is > 50mm then the threshold power value is calculated.

Note 4: Formulas round separation distance to nearest mm and power to nearest mW before determining if SAR is excluded.
