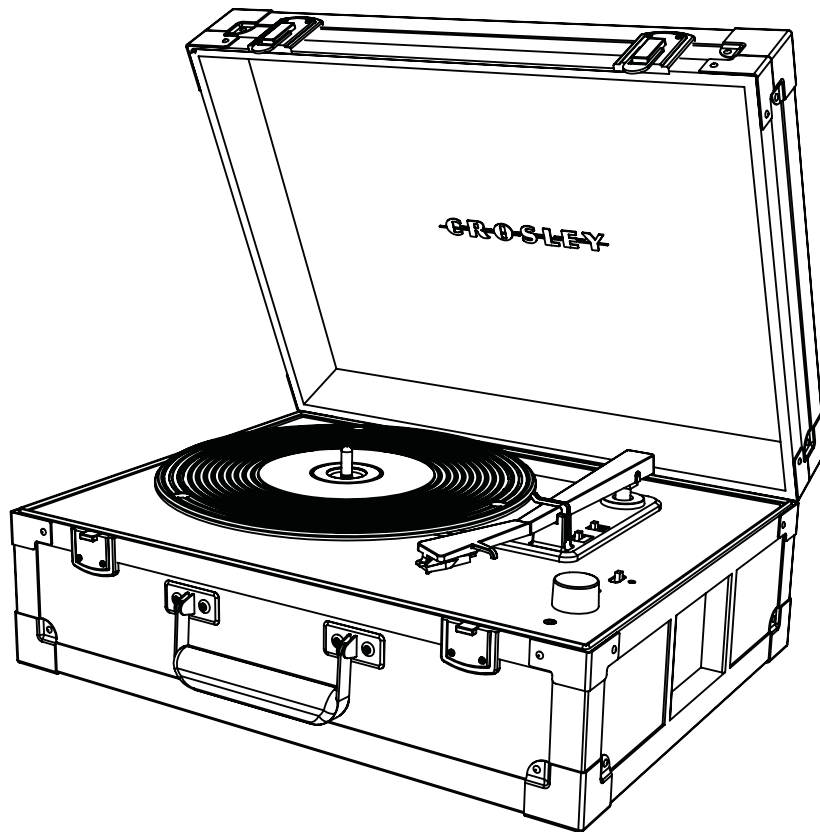

IMPORTANT SAFETY INSTRUCTION

PLEASE READ CAREFULLY ALL THE FOLLOWING IMPORTANT SAFEGUARDS THAT ARE APPLICABLE TO YOUR EQUIPMENT




1. Read Instructions - All the safety and operating instructions should be read before the product is operated.
 2. Retain instructions - The safety and operating instructions should be retained for future reference.
 3. Heed Warnings - All warnings on the product and in the operating Instructions should be adhered to.
 4. Follow Instructions - All operating and use instructions should be followed.
 5. Cleaning - Unplug this product from the wall outlet before cleaning. Do not use liquid cleaners or aerosol cleaners. Use a damp cloth for cleaning.
 6. Attachments - Do not use attachments not recommended by the product manufacturer as they may cause hazards.
 7. Water and Moisture - Do not use this product near water - for example, near a bath tub, wash bowl, kitchen sink, or laundry tub; in a wet basement; or near a swimming pool; and the like.
 8. A product and cart combination should be moved with care. Quick stops, excessive force, and uneven surfaces may cause the product and cart combination to overturn.
 9. 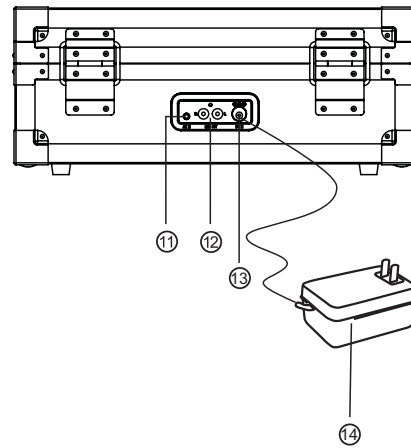
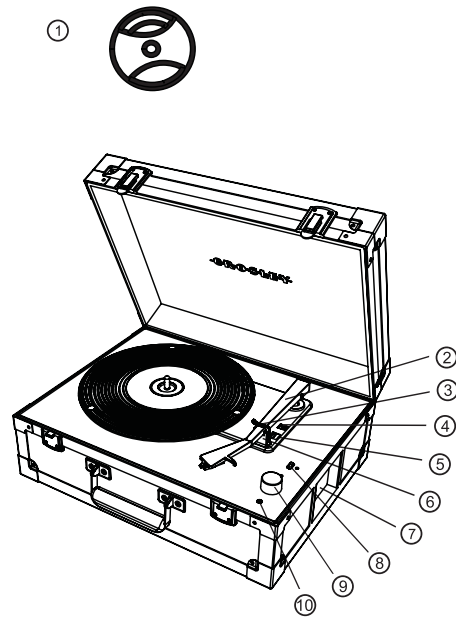

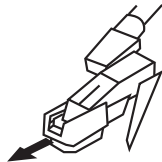
Getting Started

Unpacking

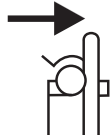
- 1 Remove packing materials from the unit.
Note: Save all packing materials.
- 2 Remove AC ADAPTER(14) from the giftbox.
- 3 Remove tie from AC ADAPTER(14).
- 4 Set the unit on its end, open the lid of the unit.



- 5 Remove black tie-warp from the bottom of the TONE ARM(2).
- 6 Remove white protective needle cover by gently pulling towards the front of the unit.



- 7 Release tone arm HOLD DOWN CLIP(3) by gently pushing to the right. This will unlock TONE ARM(2) from its arm rest. Re-lock the HOLD DOWN CLIP(3) when moving the unit to another location.



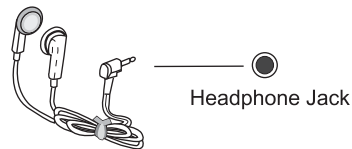
Power Source

- 1 Untie the wire on the AC ADAPTER(14).
- 2 Plug the AC ADAPTER(14) into appropriate wall outlet.
- 3 Plug the small end of the adapter into the DC JACK(13).

Headphone Jack Operation

- 1 Connect headphone to the HEADPHONE JACK(10).
- 2 Adjust volume to the desired listening level.

NOTE: When using headphone, the sound from the unit's speakers will be cut off.

Operation

Turntable Operation

- 1 Set the SPEED CONTROL SWITCH(5) to the correct speed (33 $\frac{1}{3}$, 45 or 78rpm).
- 2 Place the record on the turntable.
- 3 Move the TONE ARM(2) to the desired starting point on the record. The record will start playing.
- 4 Turn the VOLUME KNOB(9) to adjust the volume to the desired level.

Accessory: ADAPTER FOR 45 RPM

This adaptor allows you to play 45 RPM records.



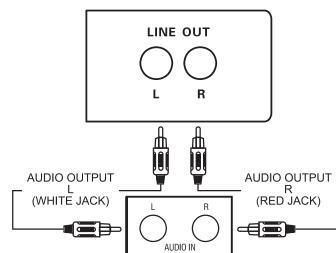
- 1 Place the 45 RPM ADAPTER(1) over the spindle.
- 2 Gently place your 45 RPM record onto the turntable.
- 3 Follow the steps under turntable operation to play your record.

Audio Output

- 1 You can play the audio from the unit into your home stereo, television or other stereo sources by using the Audio Output feature.
- 2 To make this connection, you need a standard RCA cable (not included). Plug the red and white connectors on one end of the cable into the red and white LINE OUT JACK(12) on the back of the unit. Plug other end of the cable into the Aux input jack of your selected component.
- 3 Operate the unit as usual, you can hear the sound coming from the external stereo source.

NOTE: you can still listen to your unit when using

Audio Output




AUX IN

- 1 Plug one end of the provided 3.5mm stereo cable into the AUX IN JACK(11).
- 2 Plug the other end of the stereo cable into the output jack of your desired external music device.
- 3 Check the volume level of your external device.
- 4 Refer to the user manual for correct operations of the external device to play music.

General

Bluetooth Operation

- 1 Set the Bluetooth SWITCH(8) to Bluetooth mode 
- 2 You will hear an activation tone from the unit.
- 3 Turn on the Bluetooth feature of your music device, search for Crosley CR 251A and pair.
- 4 Once your device is successfully paired with the unit, you will hear a confirmation tone from the unit.
- 5 Play and stream music from your device to the unit.

Troubleshooting

The unit does not operate.

- 1 The AC Power cord is not connected. Make sure it is connected to an AC outlet at the back of the unit.

No sound is coming from the unit.

- 1 The white protective needle cover was not removed.
- 2 Turn up the volume.
- 3 Make sure the AUX IN JACK is not plugged with a stereo cable.

Tone arm will not move.

- 1 Black tie wrap was not from underneath tone arm.
- 2 Tone arm hold down clip was not released.
