3 General Product Information

3.1 Product Function and Intended Use

The EUT are Bluetooth Speakers which support Bluetooth (dual mode) wireless technology.

According to the declaration of the applicant, The circuit principle, mainboard, bluetooth chip, and Bluetooth antenna are all identical for all models. The difference are the appearance, the type of speaker, the number of battery pack, the number of keys and so on. We choose model M03 for all RF test and other seven models for Radiated Spurious Emission (below 1GHz) & Conducted Emission test, the model M03 and the worst model M06 data show in this report.

Diagram of Measurement Configuration for Radiation Test (Below 1GHz)

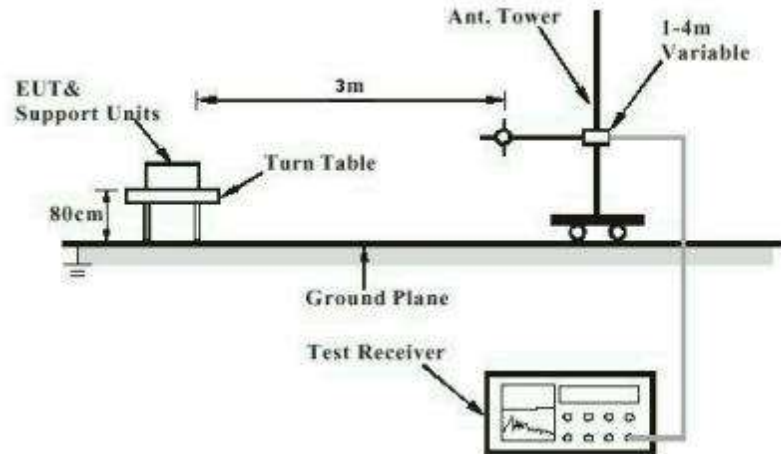


Diagram of Measurement Configuration for Radiation Test (Above 1GHz)

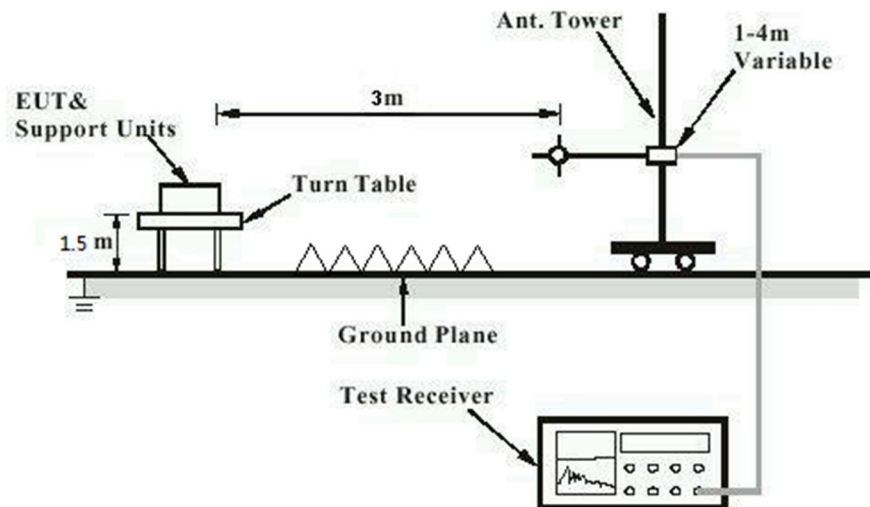


Diagram of Measurement Configuration for Mains Conduction Measurement

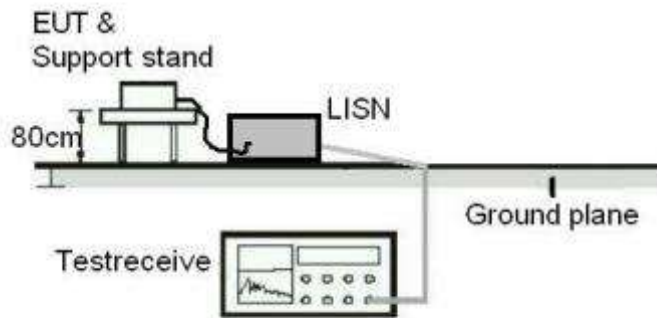
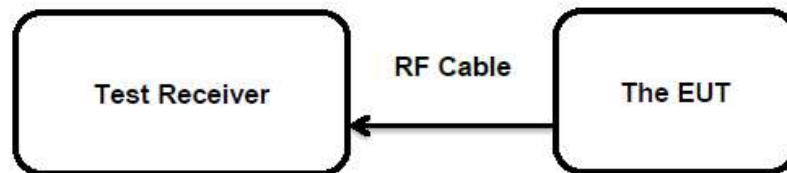


Diagram of Measurement Configuration for Conducted Transmitter Measurement
