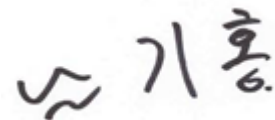

5.3 Mode of operation during the test

For the testing, software used to control the EUT for staying in continuous transmitting is programmed.

For final testing, the EUT was set at 2 402 MHz, 2 441 MHz, and 2 480 MHz to get a maximum emission levels from the EUT. The EUT was moved throughout the XY, XZ, and YZ planes and the worst case is “XY” axis, but the worst data was recorded in this report.

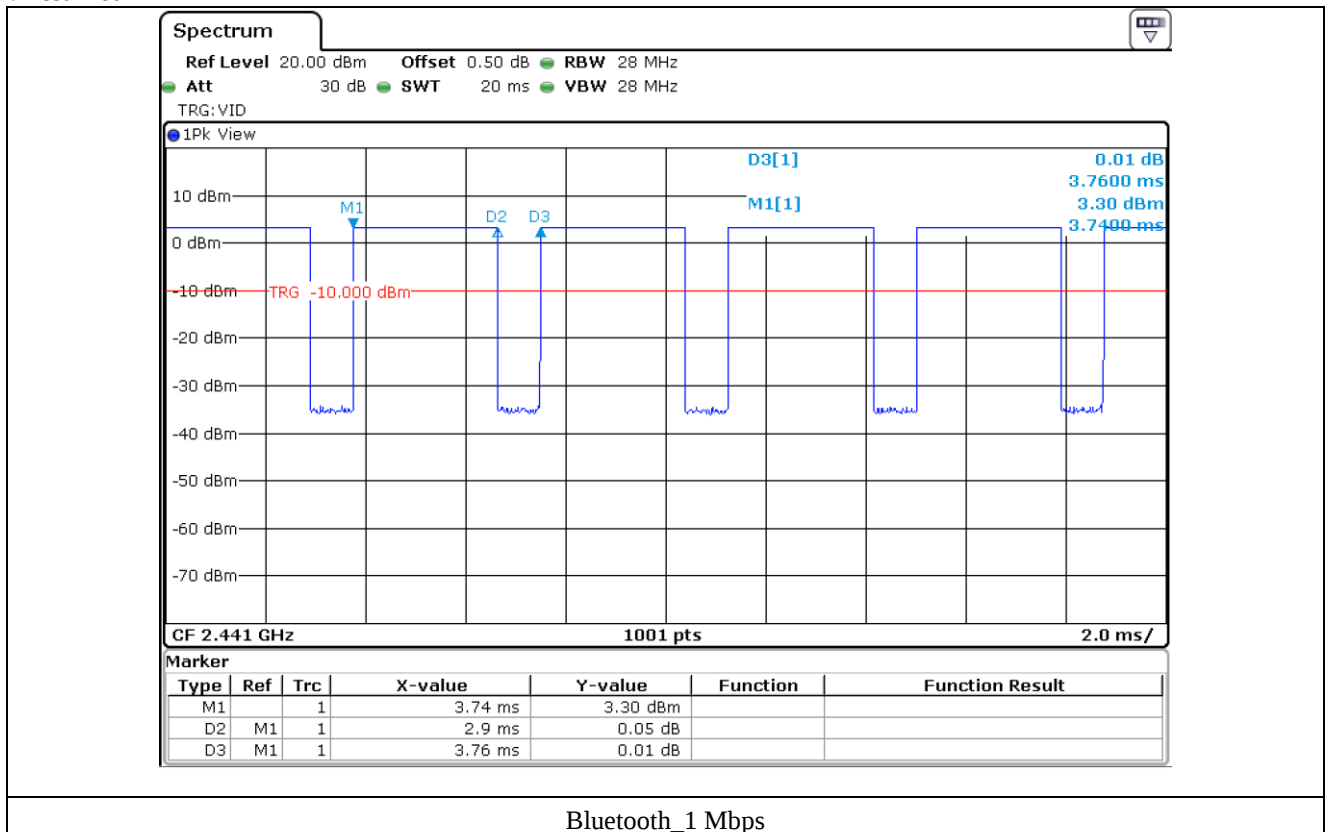

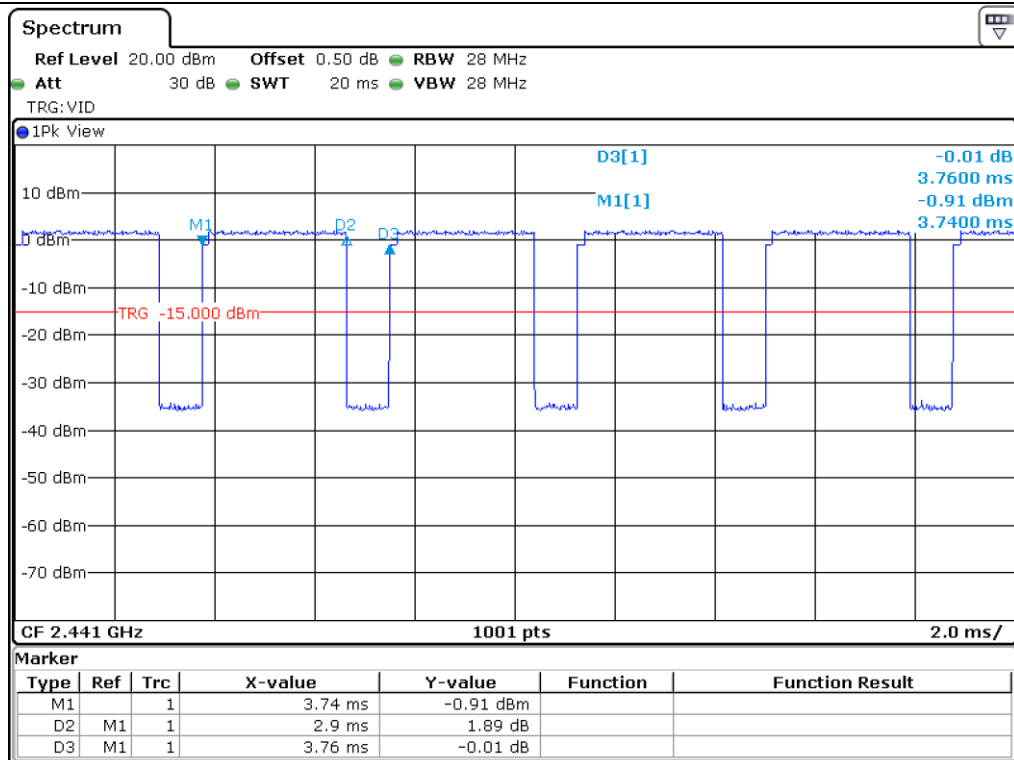

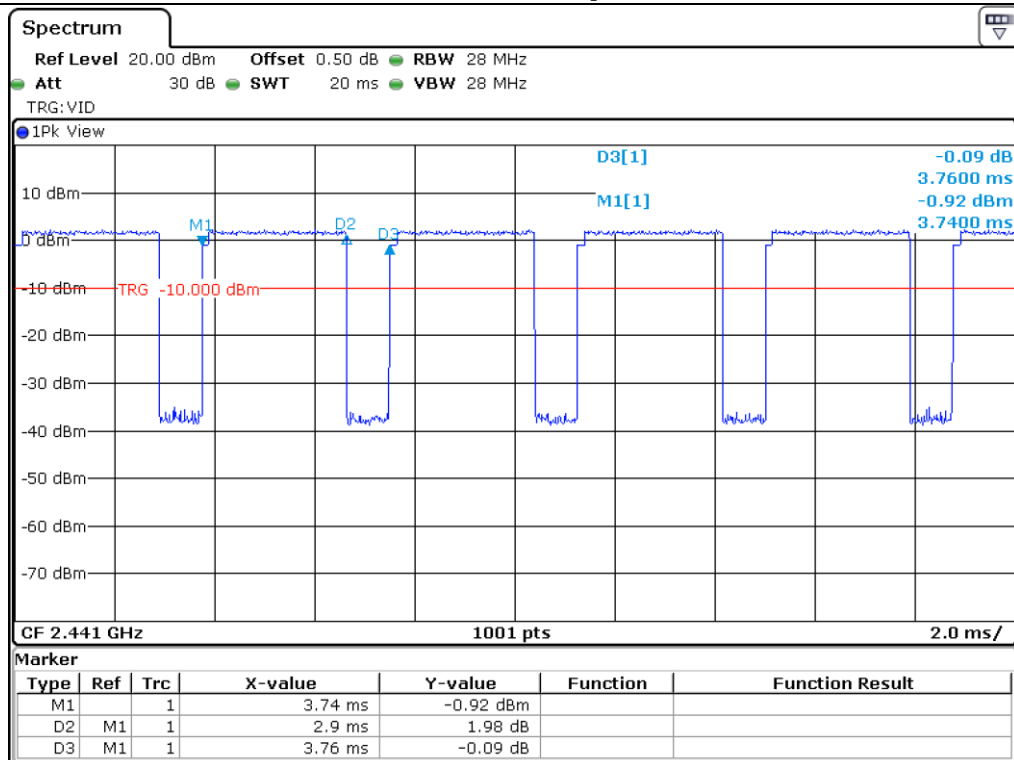

5.4 Configuration of Test System

Line Conducted Test: The EUT was tested in the Transmitting mode. All supporting equipment were connected to another LISN. Preliminary Power line Conducted Emission test was performed by using the procedure in ANSI C63.10: 2013 to determine the worse operating conditions.

Radiated Emission Test: Preliminary radiated emissions test were conducted using the procedure in ANSI C63.10: 2013 to determine the worse operating conditions. Final radiated emission tests were conducted at 3 meter Semi Anechoic Chamber.

The turntable was rotated through 360 degrees and the EUT was tested by positioned three orthogonal planes to obtain the highest reading on the field strength meter. Once maximum reading was determined, the search antenna was raised and lowered in both vertical and horizontal polarization.

5.5 Antenna Requirement

For intentional device, according to section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

Antenna Construction:

The antenna of the EUT is a Dielectric Chip Antenna on the main board in the EUT, so no consideration of replacement by the user.

The antenna output of the EUT was connected to the spectrum analyzer. The transmitter is set to operate in its normal frequency hopping mode. The center frequency of the spectrum analyzer is set to one of hopping channels near the center of the operating band and span is set to zero Hz. The sweep time is set to display one complete pulse. The mark delta function is used to measure the duration of the pulses.

12.2 Test set-up for conducted measurement

The antenna output of the EUT was connected to the spectrum analyzer. The resolution and video bandwidth is set to 100 kHz, and peak detection was used.



12.3 Test set-up for radiated measurement

The radiated emissions measurements were performed on the 3 m semi anechoic chamber. The EUT was placed on turntable approximately 1.5 m above the ground plane.

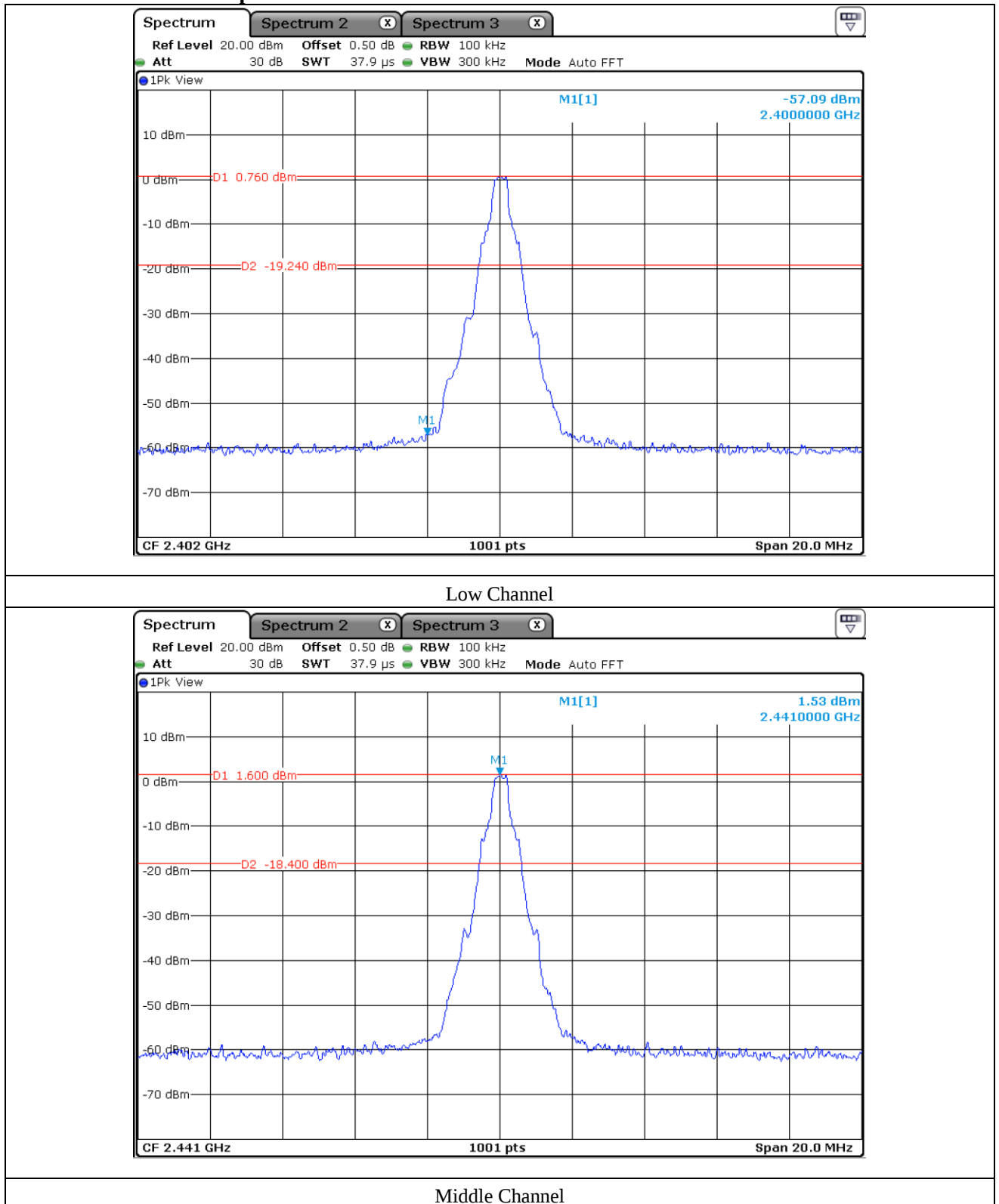
The frequency spectrum from 30 MHz to 26.5 GHz was scanned and maximum emission levels at each frequency recorded. The system was rotated 360°, and the antenna was varied in the height between 1.0 m and 4.0 m in order to determine the maximum emission levels. This procedure was performed for horizontal and vertical polarization of the receiving antenna.

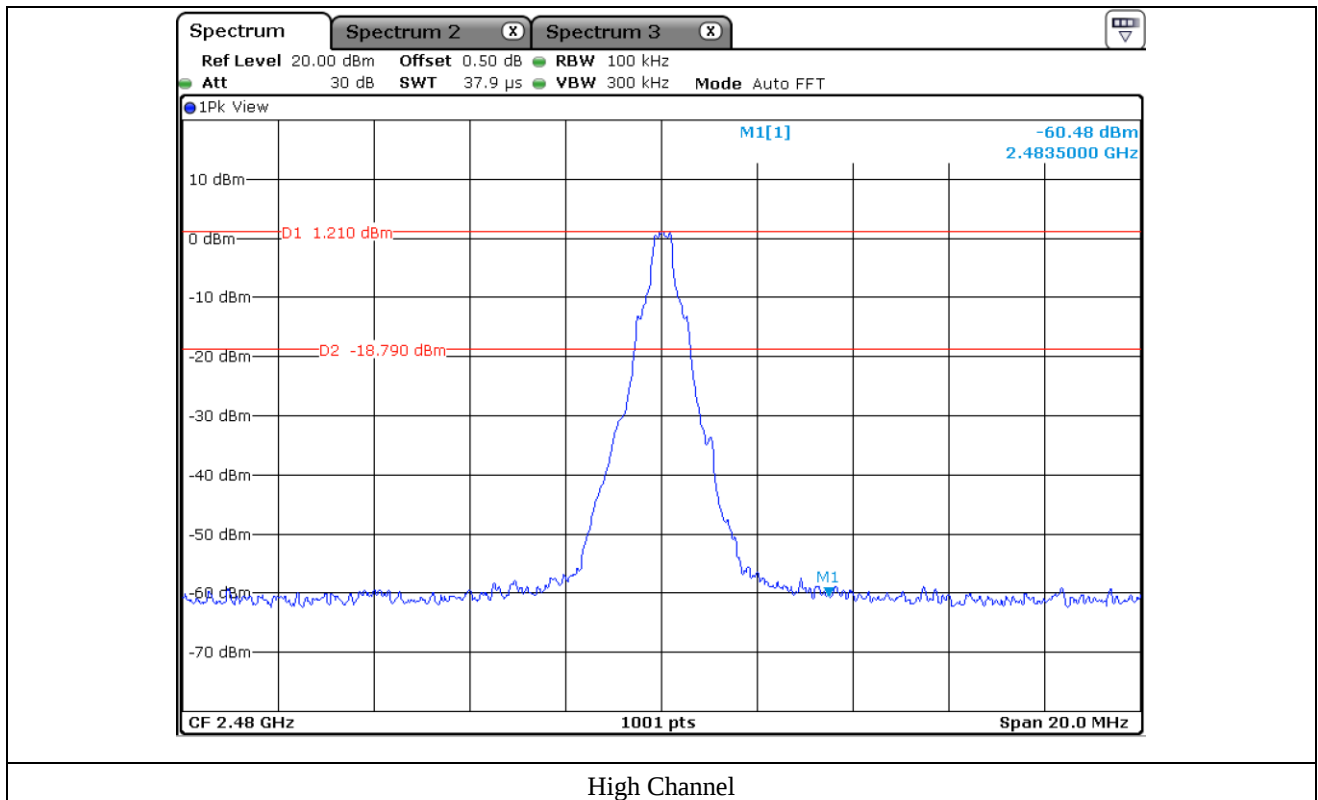

13. RADIATED EMISSION TEST

13.1 Operating environment

Temperature : 24 °C
Relative humidity : 48 % R.H.

13.2 Test set-up

The radiated emissions measurements were on the 3 m semi anechoic chamber. The EUT and other support equipment were placed on a non-conductive turntable above the ground plane. The interconnecting cables from outside test site were inserted into ferrite clamps at the point where the cables reach the turntable.

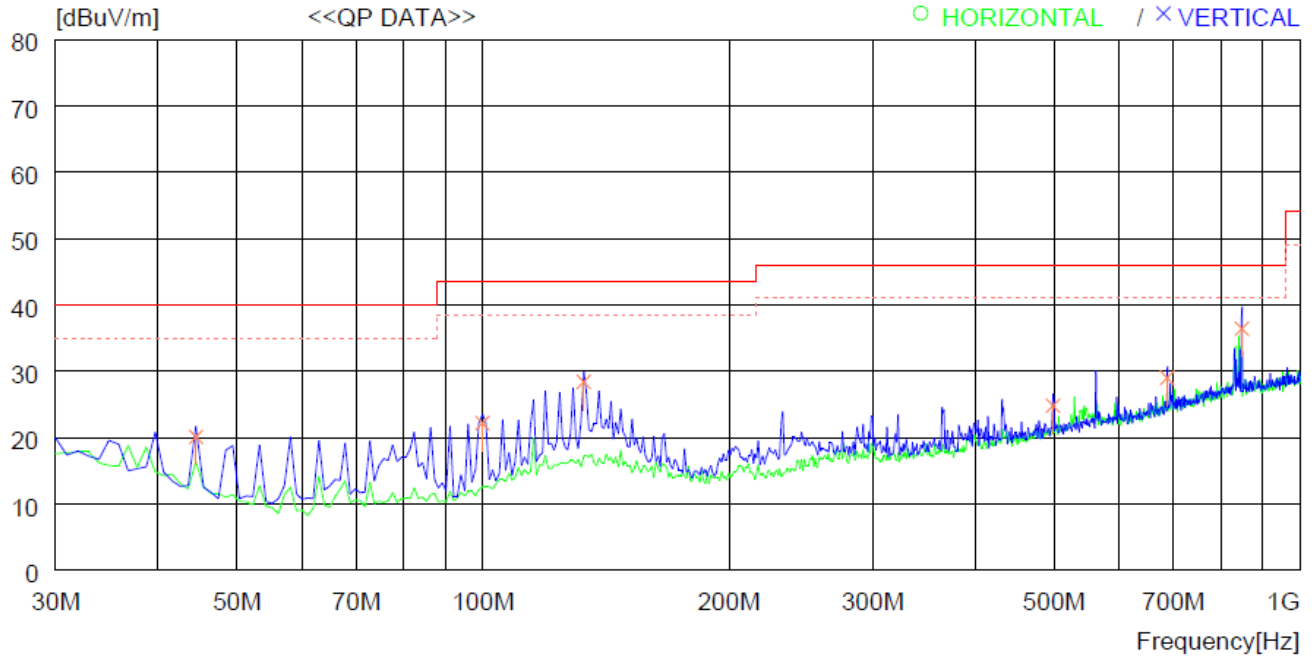
The frequency spectrum from 30 MHz to 26.5 GHz was scanned and emission levels maximized at each frequency recorded. The system was rotated 360°, and the antenna was varied in height between 1.0 m and 4.0 m in order to determine the maximum emission levels. This procedure was performed for both horizontal and vertical polarization of the receiving antenna.

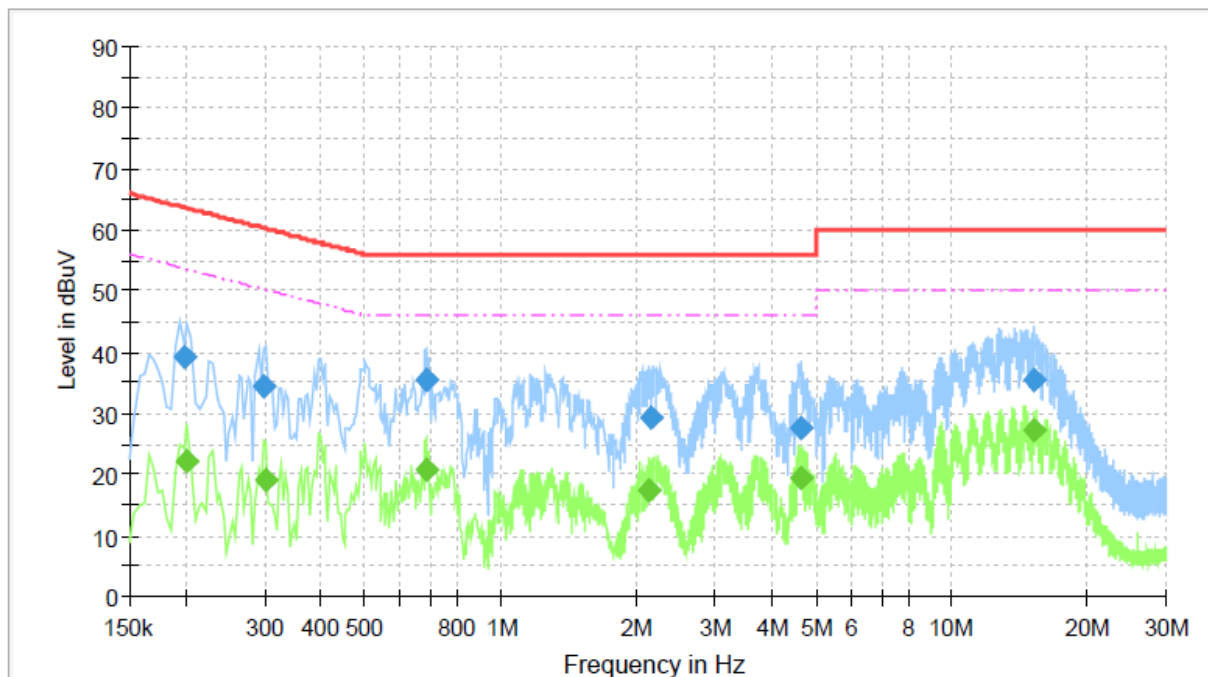
The EUT was placed on a wooden table, 0.8 m height above the floor. Power was fed to the EUT through a $50\ \Omega$ / $50\ \mu\text{H}$ + $5\ \Omega$ Artificial Mains Network (AMN). The ground plane was electrically bonded to the reference ground system and all power lines were filtered from ambient.

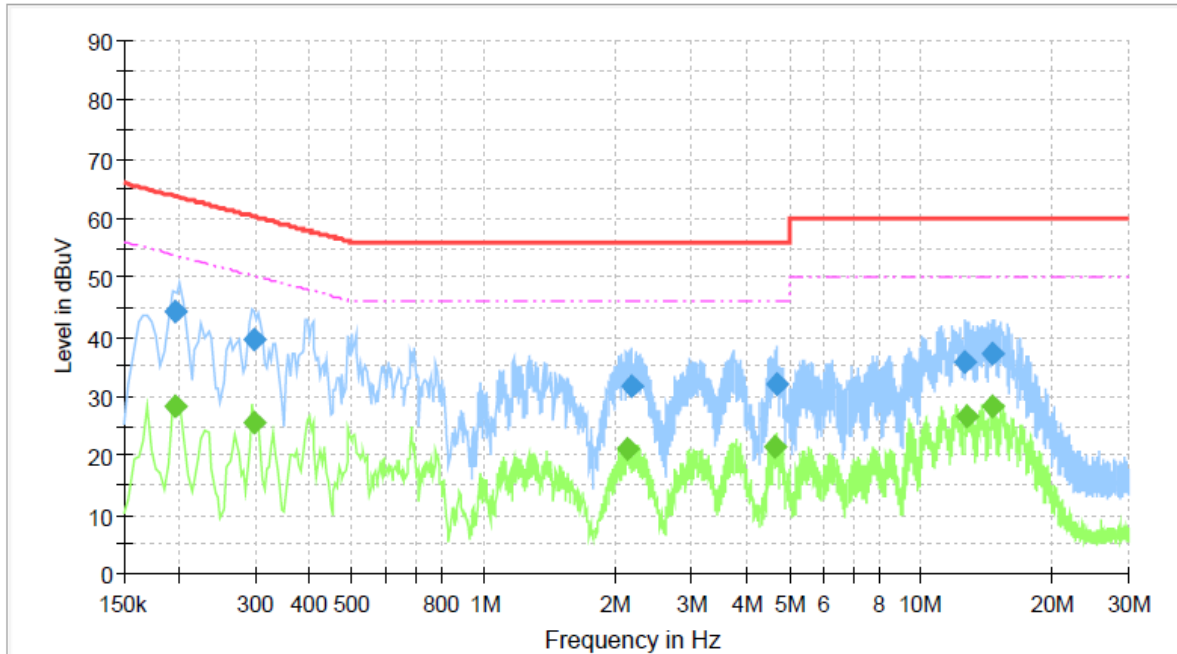
