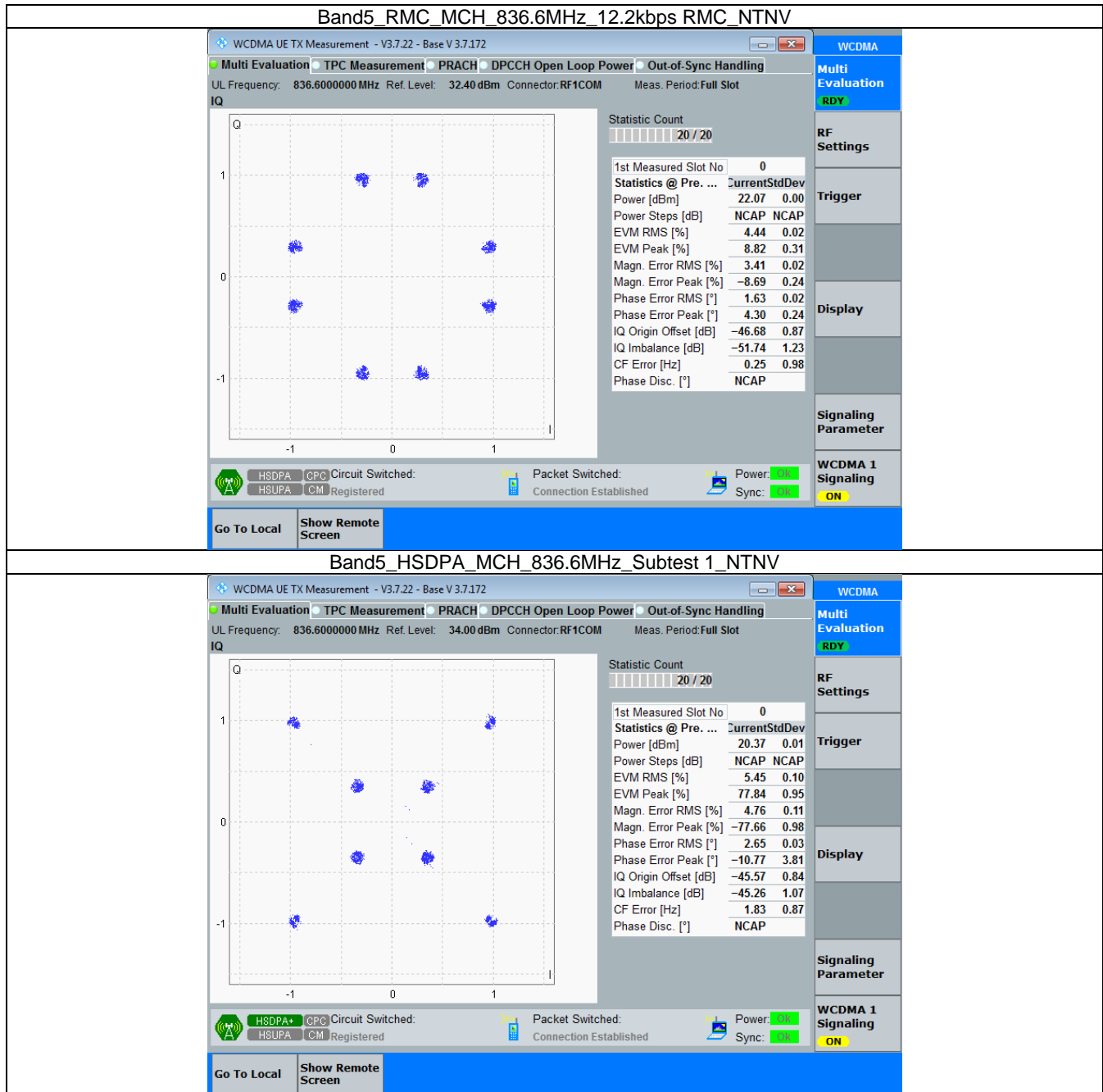

## 3.1.2 Test Graph

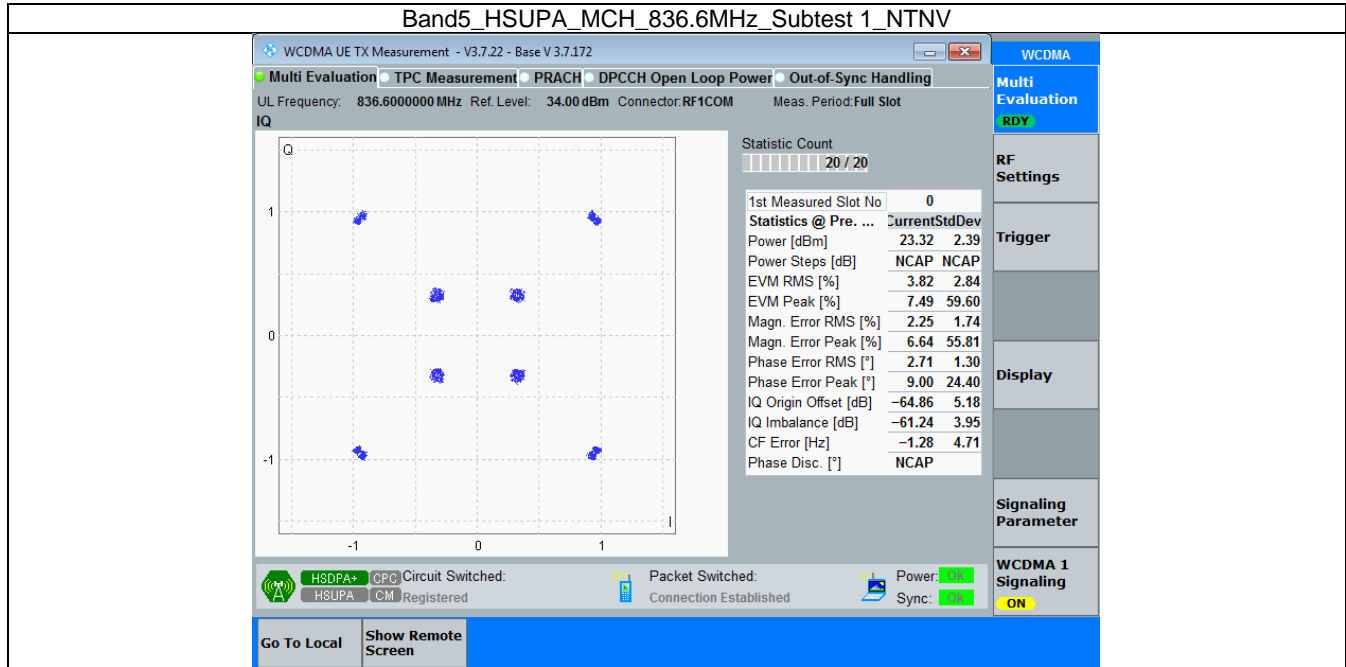

Band5\_HSDPA\_MCH\_836.6MHz\_Subtest 1\_NTNV



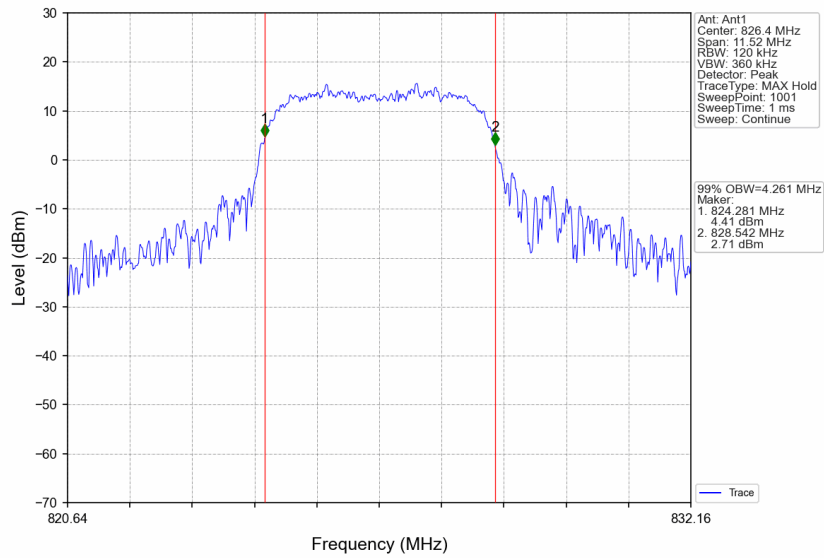

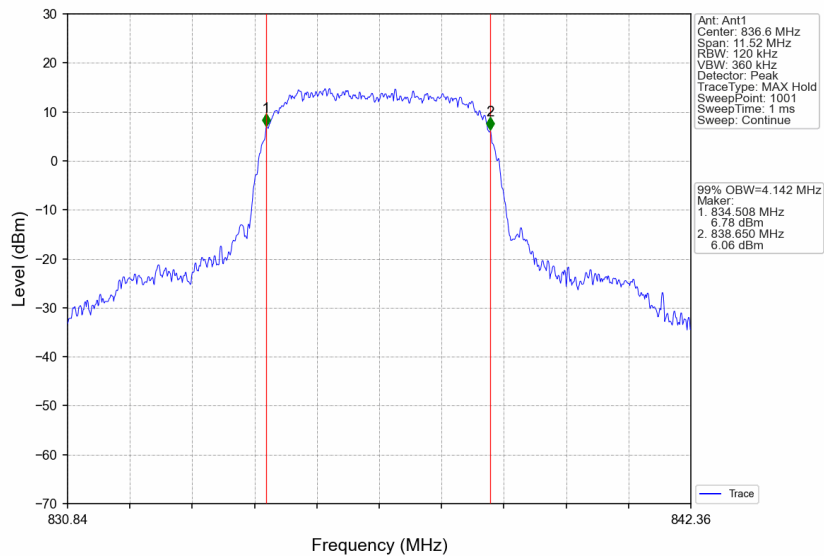

Band5\_HSUPA\_LCH\_826.4MHz\_Subtest 1\_NTNV



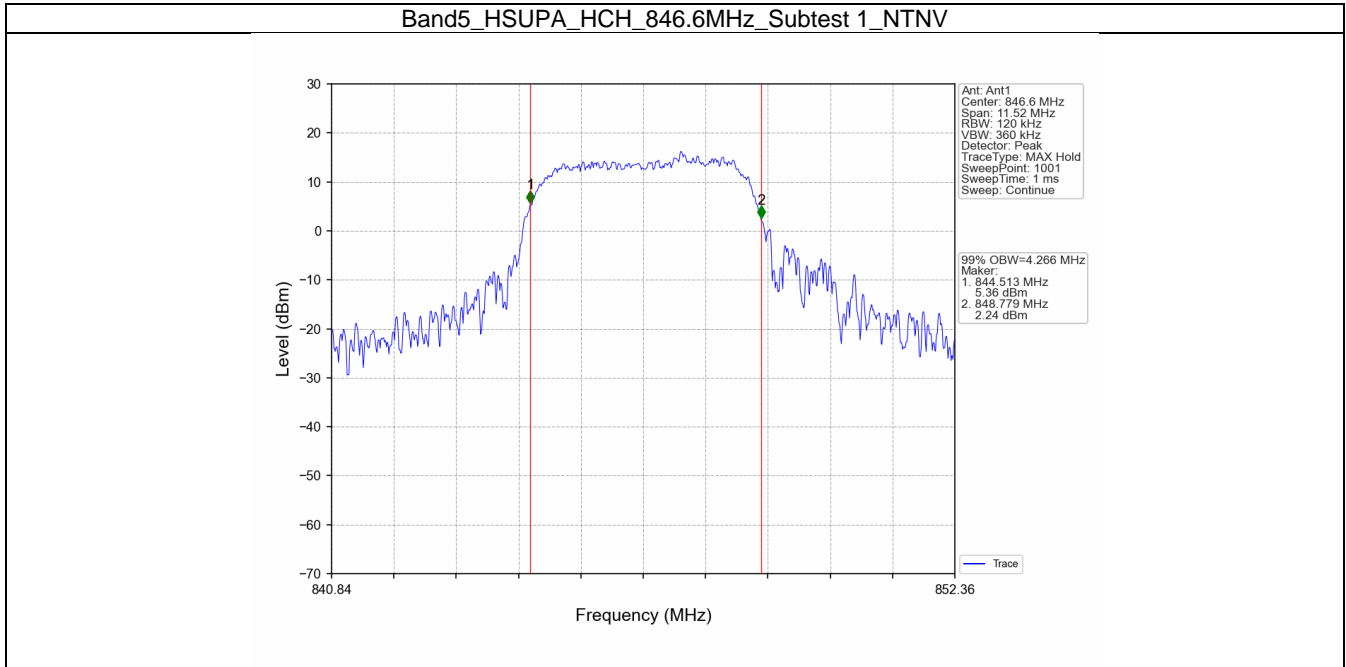
