3. Description of test modes







7. Radiated Emission Test

7.1 Measurement Procedure

- 1. The testing follows the guidelines in ANSI C63.10-2013.
- 2. Below 1000MHz, The EUT was placed on a turn table which is 0.8m above ground plane. And above 1000MHz, The EUT was placed on a styrofoam table which is 1.5m above ground plane.
- 3. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
- 4. The EUT was arranged to its worst case and then tune the Antenna tower (From 1m to 4m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level.
- 5. For measurement below 1GHz, if the emission level of the EUT measured by the peak detector is 3dB lower than the applicable limit, the peak emission level will be reported. Otherwise, the emission measurement will be repeated using the quasi-peak detector and reported.
- 6. Final measurement (Above 1GHz): The frequency range will be divided into different sub ranges depending of the frequency range of the used horn antenna. The EMI Receiver set to peak and average mode and a resolution bandwidth of 1MHz. The measurement will be performed in horizontal and vertical polarization of the measuring antenna and while rotating the EUT in its vertical axis in the range of 0 degree to 360 degree in order to have the antenna inside the cone of radiation.
- 7. Test Procedure of measurement (For Above 1GHz):
 - 1) Monitor the frequency range at horizontal polarization and move the antenna over all sides of the EUT(if necessary move the EUT to another orthogonal axis).
 - 2) Change the antenna polarization and repeat 1) with vertical polarization.
 - 3) Make a hardcopy of the spectrum.
 - 4) Measure the frequency of the detected emissions with a lower span and resolution bandwidth to increase the accuracy and note the frequency value.
 - 5) Change the analyser mode to Clear/ Write and found the cone of emission.
 - 6) Rotate and move the EUT, so that the measuring distance can be enlarged to 3m and the antenna will be still inside the cone of emission.
 - 7) Measure the level of the detected frequency with the correct resolution bandwidth, with the antenna polarization and azimuth and the peak and average detector, which causes the maximum emission.
 - 8) Repeat steps 1) to 7) for the next antenna spot if the EUT is larger than the antenna beamwidth.






(A) Radiated Emission Test Set-Up, Frequency Below 30MHz

The measurement procedure at the ban edges was simplified by performing the measurement in just one plot. Both, the in-band-emission and the unwanted emission were be encompassed by the span. After trace stabilization, the maximum peak was be determined by a peak detector and the value was marked by an appropriate limit line. The second limit line, which is 20dB below the first, marks the limit for the emissions in the unrestricted band. 12 Antenna Application

12.1 Antenna requirement

The EUT'S antenna is met the requirement of FCC part 15C section 15.203 and 15.247.

FCC part 15C section 15.247 requirements:

Systems operating in the 2402-2480MHz band that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.

12.2 Result

The EUT's antenna, permanent attached antenna, used a ceramic antenna and integrated on PCB, The antenna's gain is 1.87dBi and meets the requirement.




