4. Genera Information

4.1. Test environment and mode

Engineering mode:	Keep the EUT in continuous transmitting by select channel and modulations(The value of duty cycle is 98.46%) with Fully-charged battery.

The sample was placed (0.1m below 1GHz, 1.5m above 1GHz) above the ground plane of 3m chamber. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating the turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.

4.2. Description of Support Units

The EUT has been tested as an independent unit together with other necessary accessories or support units. The following support units or accessories were used to form a representative test configuration during the tests.

Test Procedure:	 The RF exposure test was performed on 360 degree turn table in anechoic chamber. The measurement probe was placed at test distance (10cm) which is between the edge of the charger and the geometric centre of probe. The turn table was rotated 360d degree to search of highest strength. The highest emission level was recorded and compared with limit as soon as measurement of each points (A, B, C, D, E) were completed. The EUT were measured according to the dictates of KDB 680106D01v02.
