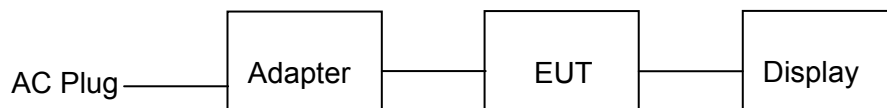

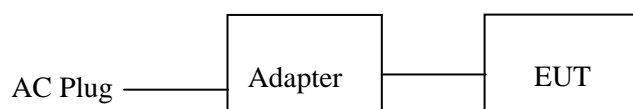

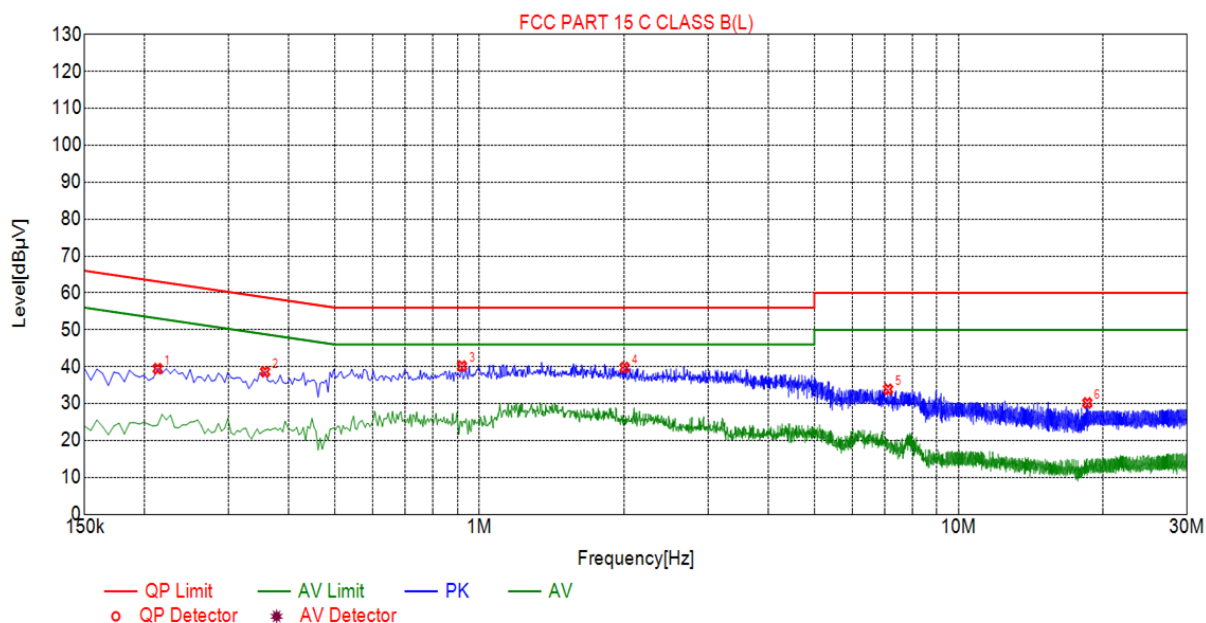

Conducted Emission on Line Terminal of the power line (150 kHz to 30MHz)



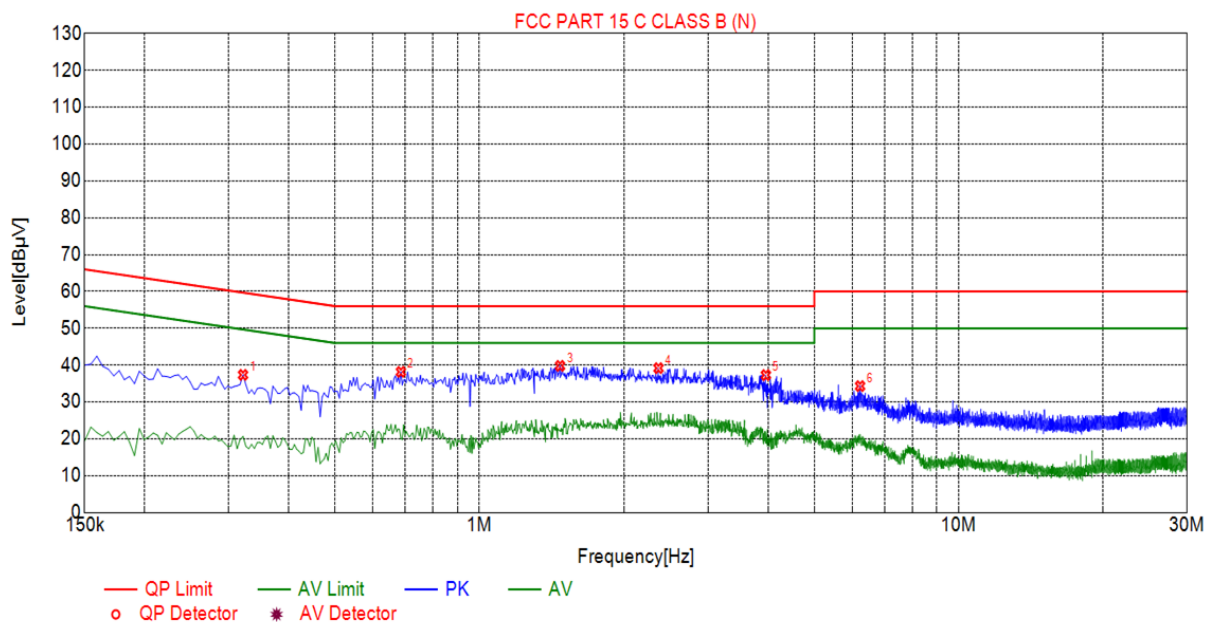

WIFI ANTENNA



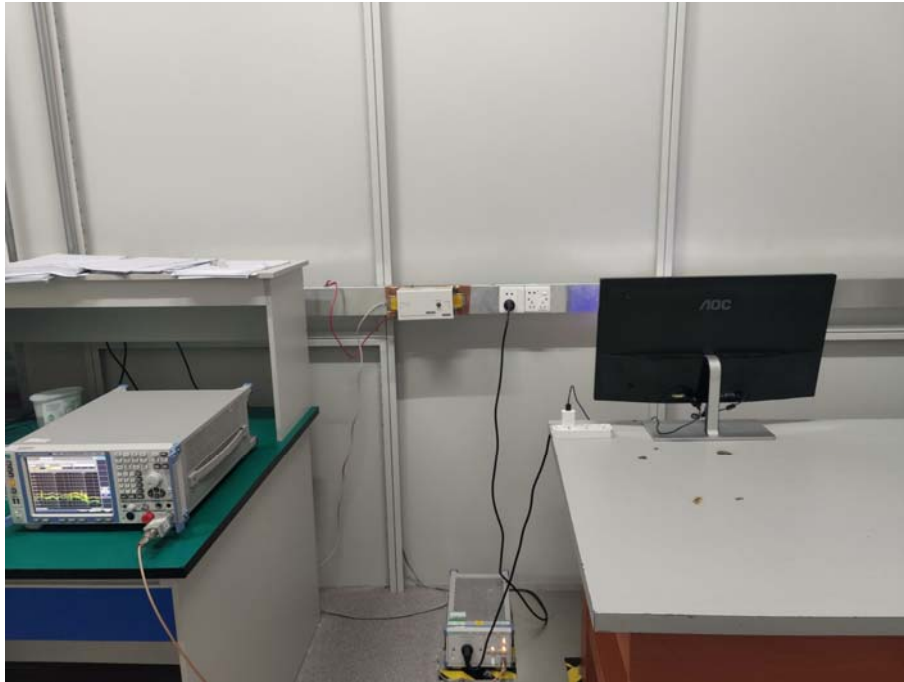
