Getting Started

System Requirements

- iOS 8.0 or later
- Android version 4.3 or later
- Bluetooth® 4.0 or later

Charging the Activity Tracker

Remove the activity tracker from its band by pulling out the side with the button first, and then the other side. Insert the activity tracker's attached USB charging piece **with the charging contacts pointing down** into a USB power port such as the USB port on a computer, or into a compatible **5V charging adapter** (not included) and plug into a wall outlet.

Powering ON/OFF

- Press + hold the button on the side of the activity tracker to power ON or OFF.
- Be sure to charge the activity tracker fully before using for the first time.

Setting Up with a Smart Device

1. Power the activity tracker ON. Enable Bluetooth on your smart device, and search for new devices to pair with.
2. Go to the App Store on your smart device and search for "Lefun Health". Install the free app on your device.
3. Open the app on your device. Tap the menu bar in the top left corner, and tap "Device name / connection status." When it appears, select **SIT50** to connect to the activity tracker.

After the activity tracker is connected successfully, it will sync the time and date from your smart device.

The app can sync information from the activity tracker such as the pedometer, sleep monitor, and more. See the **Tracker Functions** section on the next page for a full list.

Tracker Functions

Press the button on the activity tracker to switch between modes and functions. The following functions can be used on the activity tracker:

- **Home page:** displays the time, date and battery level
- **Smart alarm clock:** Set alarm in app, tracker will vibrate alarm
- **Pedometer:** Counts daily steps and resets every 24 hours. Pedometer history is recorded in the app.
- **Calories:** Counts daily calories and resets every 24 hours. Calories history is recorded in the app.
- **Mileage:** Tracks distance traveled daily and resets every 24 hours.
- **Heart rate monitor:** Measures heart rate and records in the app.
- **Blood pressure monitor:** Measures blood pressure and records in the app.
- **Sleep monitor:** Records sleeping status and stores in the app.
- **Movement reminder:** Turn on and set a time to get reminders to get moving.
- **Hydration reminder:** Turn on and set a time to get reminders to drink water.
- **Smart anti-loss function:** Turn on and the tracker will vibrate when the connected smart device moves too far away.
- **Message & call notifications:** The tracker will vibrate when the connected smart device receives a message or incoming call.
- **"Shake for selfie" function:** When turned on, shake the tracker to take a photo on the connected smart device.
