1. Remove reader from (blue/white/gray) box and plastic polybag.

2. Plug USB into USB port on the console.

3. Turn on console and insert game disc.

4. Start Game.

6. Follow in game instructions and place all three characters (Batman, Wyldstyle, Gandalf) on the left or right sides of the reader. Reader will light up as you place each character down.
