Band-edge for RF Conducted Emissions_DH5_2402_Hopping On

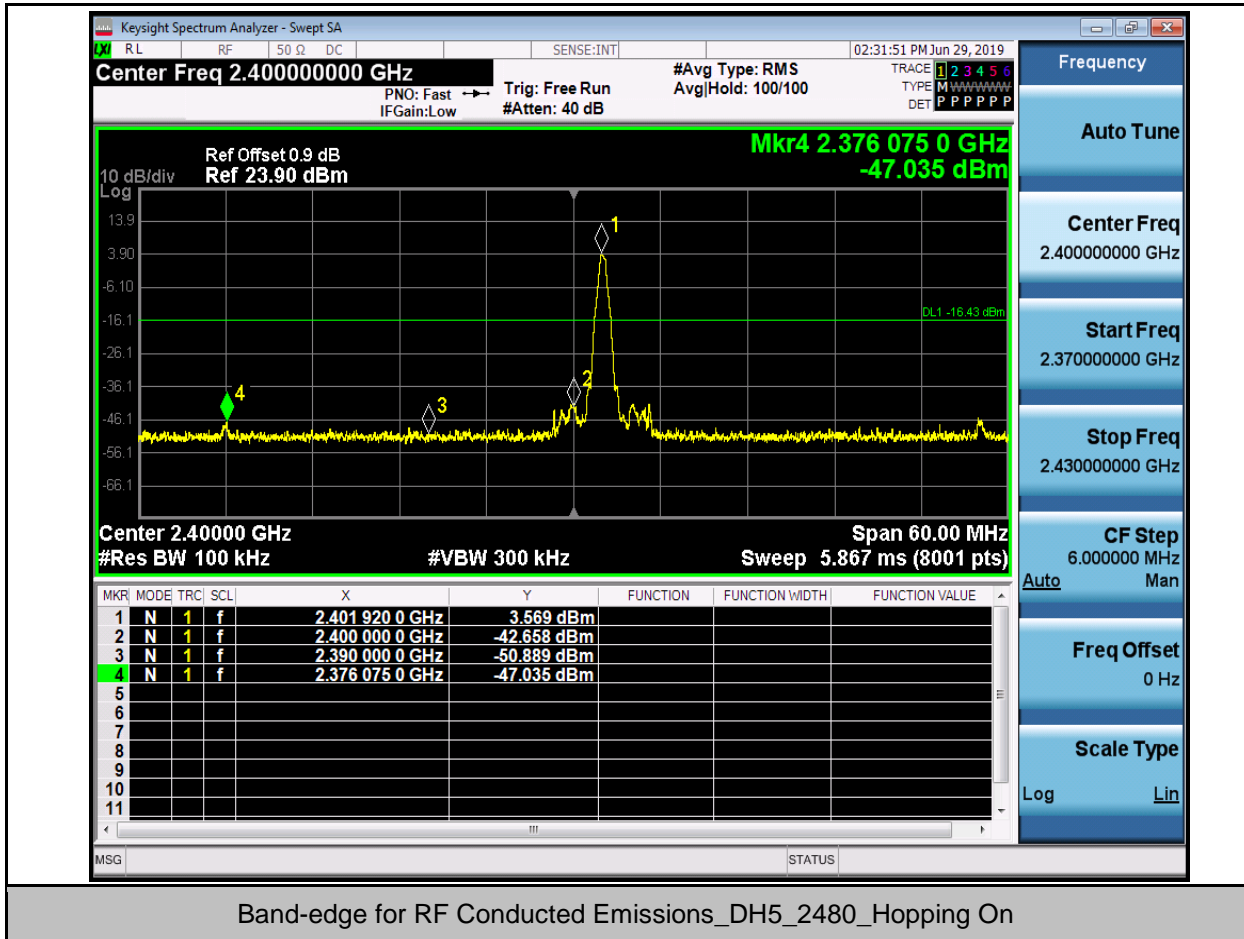


Band-edge for RF Conducted Emissions_DH5_2402_Hopping Off



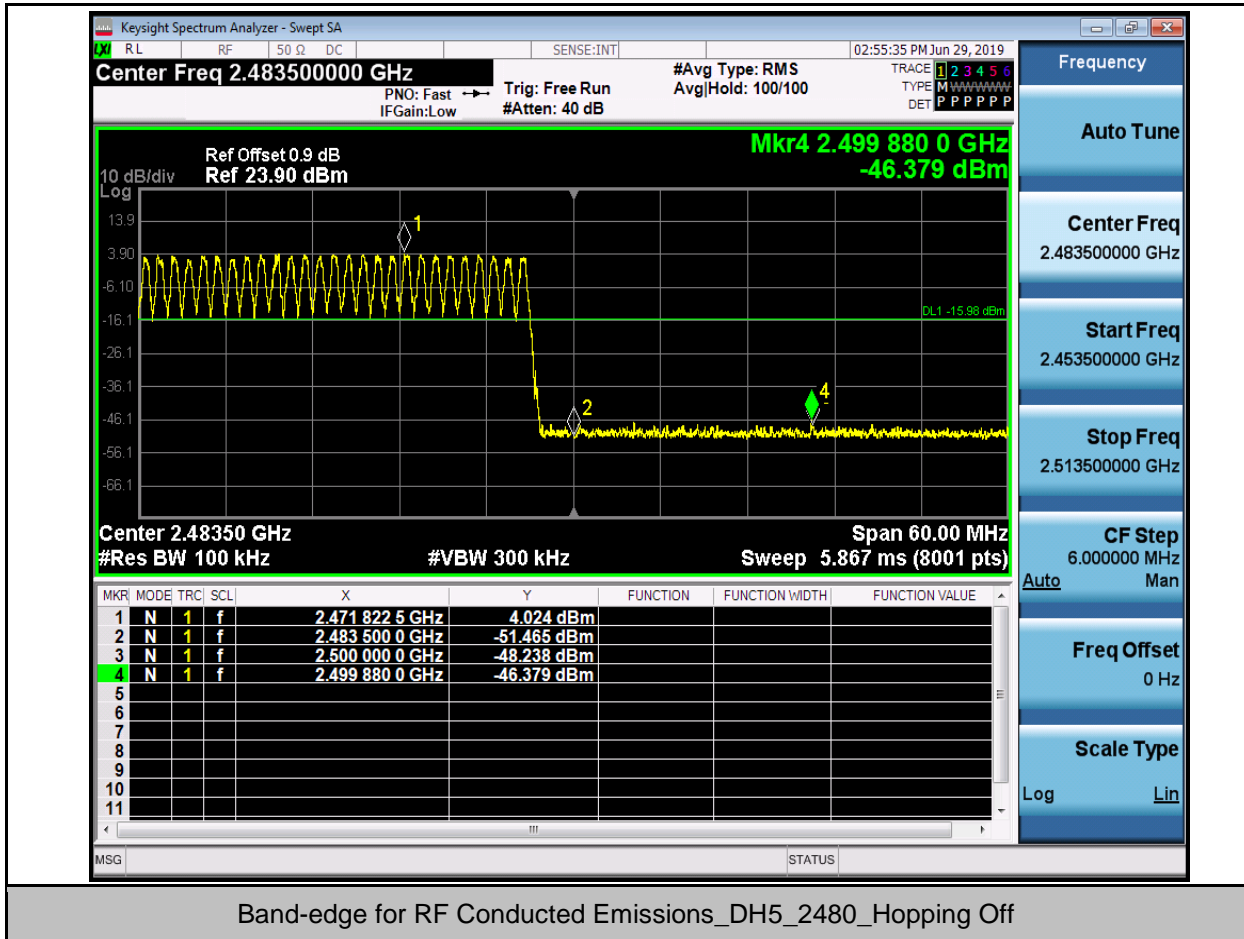
