





AC 120V/60 Hz, Line







Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All final data was recorded in Quasi-peak detection mode for frequency range of 30 MHz -1 GHz and peak and Average detection modes for frequencies above 1 GHz.

Corrected Amplitude & Margin Calculation






Pre-scan with 2441 MHz




Average value for the peak point at pre-scan


Average value for the peak point at pre-scan








Average value for the peak point at pre-scan

FCC §15.247(a) (1)-CHANNEL SEPARATION TEST

Applicable Standard

Frequency hopping systems shall have hoping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater provided the systems operate with an output power no greater than 125 mW.


BDR (GFSK): High Channel

EDR ($\pi/4$ -DQPSK): Low Channel




EDR ($\pi/4$ -DQPSK): Low Channel

EDR ($\pi/4$ -DQPSK): Middle Channel




Pulse time, High Channel, DH1




Pulse time, Middle Channel, DH3




Pulse time, Low Channel, DH5


Pulse time, Middle Channel, 2DH1




Pulse time, Low Channel, 2DH3

Pulse time, Middle Channel, 2DH3




Pulse time, High Channel, 2DH3




Pulse time, Middle Channel, 2DH5
