## NOTICE

- Please do not share this vibrating butt plug with other people to avoid bacterial infection.
- Clean the product thoroughly before and after each use.
- To improve stimulation, use this vibrating butt plug with water or silicone based lubricant.
- Do not overuse this product for a long period of time as the motor may overheat.



## SET UP

Connect the USB cable to the bottom of the Zeus to charge the device. LED light will remain switched on as it is charging. The LED light will turn off once Zeus is fully charged.

Once the product is fully charged, screw on the suction cup as required. Your Zeus is now ready for use.

There are 4 steps to using Zeus. Please note that this device has a standby mode. Also the power button on the vibrator and remote control are interchangeable. Hence the below instructions applies to both.

- Step 1: press the power button once, the LED light will start flashing. The device is now in standby mode. Press the power button again for Zeus to start vibrating.
- Step 2: press the power button again to change the vibration frequency. There are 10 vibration frequencies in total.
- Step 3: hold the power button for 2 seconds to go into standby mode.
- Step 4: Once it is in standby mode, hold the button for 4 seconds, the machine will vibrate for 1 second and it will switch off.



## MAINTENANCE

- Clean and dry the product after use. And keep it away from direct sunlight.
- Do NOT use brush or acid based cleaner for cleaning.
- Zeus is made from FDA approved body-safe medical grade silicone. It is 100% waterproof.



## TROUBLESHOOTING

- **Zeus does not activate when the power button is pressed?**

Ensure the product is fully charged. Also, the device may be in standby mode. Please press the button again to switch it on. If this does not resolve the issue then please contact support.

- **The sound is too loud?**

This product contains powerful motors. This provides a mild to strong stimulation for the user. Hence the vibrations may produce certain amount of sounds.

- **The vibration is not strong enough?**

This may be caused by insufficient battery power. Please connect the USB charger to charge the device.
