



Fig.4 Peak Conducted Output Power CH0, 2DH1









Fig.6 Peak Conducted Output Power CH78, 2DH1





Fig.10 Frequency Band Edge: GFSK, Ch0, Hopping OFF








Fig.12 Frequency Band Edge: GFSK, Ch78, Hopping OFF







Fig.14 Frequency Band Edge: π/4 DQPSK, Ch0, Hopping OFF





Fig.18 Frequency Band Edge: 8DPSK, Ch0, Hopping OFF








Fig.22 Conducted spurious emission: GFSK, Ch0, 2402MHz



Fig.24 Conducted spurious emission: GFSK, Ch39, 2441MHz





Fig.25 Conducted spurious emission: GFSK, Ch39, 30MHz~26GHz



Fig.26 Conducted spurious emission: GFSK, Ch78, 2480MHz







Fig.29 Conducted spurious emission: π/4 DQPSK, Ch0, 30MHz~26GHz



Fig.30 Conducted spurious emission:  $\pi/4$  DQPSK, Ch39, 2441MHz



Fig.31 Conducted spurious emission:  $\pi/4$  DQPSK, Ch39, 30MHz~26GHz



Fig.32 Conducted spurious emission:  $\pi/4$  DQPSK, Ch78, 2480MHz



Fig.33 Conducted spurious emission:  $\pi/4$  DQPSK, Ch78, 30MHz~26GHz



Fig.34 Conducted spurious emission: 8DPSK, Ch0, 2402MHz



Fig.35 Conducted spurious emission: 8DPSK, Ch0, 30MHz~26GHz



Fig.36 Conducted spurious emission: 8DPSK, Ch39, 2441MHz







The preferred area occupied by the EUT arrangement is 1 m by 1.5 m, For emissions testing at or below 1 GHz, the table height shall be 80 cm above the reference ground plane. For emission measurements above 1 GHz, the table height shall be 1.5 m. but it may be larger or smaller to accommodate various sized EUTs. For testing purposes, ceiling- and wall-mounted devices also shall be positioned on a tabletop (see also ANSI C63.10-2013 section 6.3.4 and 6.3.5). In making any tests involving handheld, body-worn, or ceiling-mounted equipment, it is essential to recognize that the measured levels may be dependent on the orientation (attitude) of the three orthogonal axes of the EUT. Thus, exploratory tests as specified in 8.3.1 shall be carried out for various axes orientations to determine the attitude having maximum or near-maximum emission level.

The EUT was placed on a non-conductive table. The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and the EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. This maximization process was repeated with the EUT positioned in each of its three orthogonal orientations.






Fig.40 Radiated emission: GFSK, Ch78, 30MHz~1GHz




Fig.41 Radiated emission: GFSK, Ch78, 1GHz~3GHz





Fig.42 Radiated emission: GFSK, Ch78, 3GHz~18GHz










Fig.43 Radiated emission (Low): GFSK, low channel




Fig.44 Radiated emission (High): GFSK, high channel




Fig.45 Radiated emission: π/4 DQPSK, Ch78, 30MHz~1GHz




Fig.46 Radiated emission: π/4 DQPSK, Ch78, 1GHz~3GHz







Fig.47 Radiated emission: π/4 DQPSK, Ch78, 3GHz~18GHz





Fig.48 Radiated emission (Low):  $\pi/4$  DQPSK, low channel








Fig.50 Radiated emission: 8DPSK, Ch78, 30MHz~1GHz




Fig.51 Radiated emission: 8DPSK, Ch78, 1GHz~3GHz





Fig.52 Radiated emission: 8DPSK, Ch78, 3GHz~18GHz





Fig.53 Radiated emission (Low): 8DPSK, low channel




Fig.54 Radiated emission (High): 8DPSK, high channel




Fig.55 Radiated emission: GFSK, Ch78, 30MHz~1GHz




Fig.56 Radiated emission: GFSK, Ch78, 1GHz~3GHz







Fig.58 Radiated emission (Low): GFSK, low channel





Fig.59 Radiated emission (High): GFSK, high channel







Fig.60 Time of occupancy (Dwell Time): Ch39, Packet DH1








Fig.62 Time of occupancy (Dwell Time): Ch39, Packet DH3








Fig.64 Time of occupancy (Dwell Time): Ch39,Packet DH5








Fig.66 Time of occupancy (Dwell Time): Ch39, Packet 2-DH1








Fig.68 Time of occupancy (Dwell Time): Ch39,Packet 2-DH3







Fig.70 Time of occupancy (Dwell Time): Ch39, Packet 2-DH5





Fig.74 Time of occupancy (Dwell Time): Ch39,Packet 3-DH3





Fig.78 20dB Bandwidth: GFSK, Ch0






Fig.80 20dB Bandwidth: GFSK, Ch78



Fig.81 20dB Bandwidth: π/4 DQPSK, Ch0



Fig.82 20dB Bandwidth: π/4 DQPSK, Ch39











Fig.86 20dB Bandwidth: 8DPSK, Ch78






Fig.87 Carrier separation measurement: GFSK, Ch39







Fig.90 Number of hopping frequency: GFSK, Ch0~39






Fig.91 Number of hopping frequency: GFSK, Ch40~78



Fig.92 Number of hopping frequency:  $\pi/4$  DQPSK, Ch0~39








