
Peak Power Measurement

The maximum peak conducted output power may be measured using a broadband peak RF power meter. The power meter shall have a video bandwidth that is greater than the occupied bandwidth.

Method AVGPM-G (Average Power Measurement)

Average power measurements were performed only when the EUT was transmitting at its maximum power control level using a broadband power meter with a pulse sensor. The power meter implemented triggering and gating capabilities which were set up such that power measurements were recorded only during the ON time of the transmitter. The trace was averaged over 100 traces to obtain the final measured average power.

6.4.2 Test Description

The Equipment under Test (EUT) was set up in a shielded room to perform the dwell time measurements.

The EUT was connected to the spectrum analyzer and Bluetooth test set via a power splitter with a known loss.

The time slot length is measured of three different packet types which are available in the Bluetooth technology. Those are DH1, DH3 and DH5 packets. The dwell time is calculated by:

Dwell time = time slot length * hop rate * 31.6/ number of hopping channels with:

- hop rate=1600/2 * 1/s for DH1 packets =800
- hop rate=1600/4 * 1/s for DH3 packets =400
- hop rate=1600/6 * 1/s for DH5 packets =266.67
- Number of hopping channels=79
- 31.6 s=0.4 seconds multiplied by the number of hopping channels=0.4s * 79







- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at chamber room. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. Both X and Y axes of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Quasi-Peak Detect Function and recorded the reading with Maximum Hold Mode.

For Radiated emission above 30MHz

- a. The EUT was placed on the top of a rotating table 0.8 meters (for $30MHz \sim 1GHz$) / 1.5 meters (for above 1GHz) above the ground in chamber room for test. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The height of antenna is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to quasi-peak detect function and recorded the reading with Maximum Hold Mode when the test frequency is below 1 GHz.

Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staving aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.







For Radiated emission 30MHz to 1GHz





6.9.3 Test Procedures

- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.
- c. The frequency range from 150 kHz to 30MHz was searched. Emission levels under (Limit 20dB) were not recorded.




Carrier frequency (MHz): 2441 Channel No.:39 Modulation type: GFSK










Carrier frequency (MHz): 2441 Channel No.:39 Modulation type: π/4DQPSK




Carrier frequency (MHz): 2480 Channel No.:78 Modulation type: π/4DQPSK






Carrier frequency (MHz): 2402 Channel No.:0 Modulation type: 8DPSK










Carrier frequency (MHz): 2441 Packet type: DH3 Modulation type: GFSK






Carrier frequency (MHz): 2441 Packet type: DH3 Modulation type: π/4DQPSK


