| <div>Limited Warranty</div> <div><p>Congratulations on your purchase of a Keen Home Smart Bridge! We have some important information we would like to share with you.</p><p>YOU SHOULD READ THIS—IT HAS IMPORTANT INFORMATION ABOUT YOUR RIGHTS AND OBLIGATIONS, AND KEEN HOME'S WARRANTY POLICY.</p><p><b>1. If the Keen Home determines the Product fails to conform to this warranty, Keen Home will bear all costs of return shipping to the Product owner and will reimburse any reasonable shipping costs incurred by Product owner.
