

Rohde & Schwarz (R&S) TS8991 Antenna Measurement System includes two measurement probe broadband Horn Antennas. These measurement antennas are designed with characteristics of dual linear polarization. Together, these antennas support testing between 600 MHz and 6 GHz.

An integrated laser alignment system assists with DUT positioning. With a switch control unit integrated on the system, the test system provides fast switching between each polarization of antennas for high speed testing.
