## 6 NETWORK CONFIGURATION

### Cautions


- It is necessary to forget any other around network and make sure the Android or iOS device just connect to the Wi-Fi network you want to configure.
- Make sure the Android or iOS device Wi-Fi function works well and can be connected back to your original Wi-Fi network automatically.

### Kindly reminder:

User must finish all the steps in 8 minutes after powering on AC, otherwise you need to power on it again.

### Using Android device to do network configuration

- ① Make sure your mobile device has already been connect to the Wi-Fi network which you want to use. Also, you need to forget other irrelevant Wi-Fi network in case it influences your configuration process.
- 2 Disconnect the power supply of AC.
- ③ Connect the power supply of AC, and continuously press the "LED DISPLAY" or "DO NOT DISTURB" button seven times in 10 seconds.
- When the AC displays 'AP', it means that the AC Wi-Fi has already entered into 'AP' Mode.
- Some type of AC do not need the ② step to be in AP mode







#### Using iOS device to do network configuration




