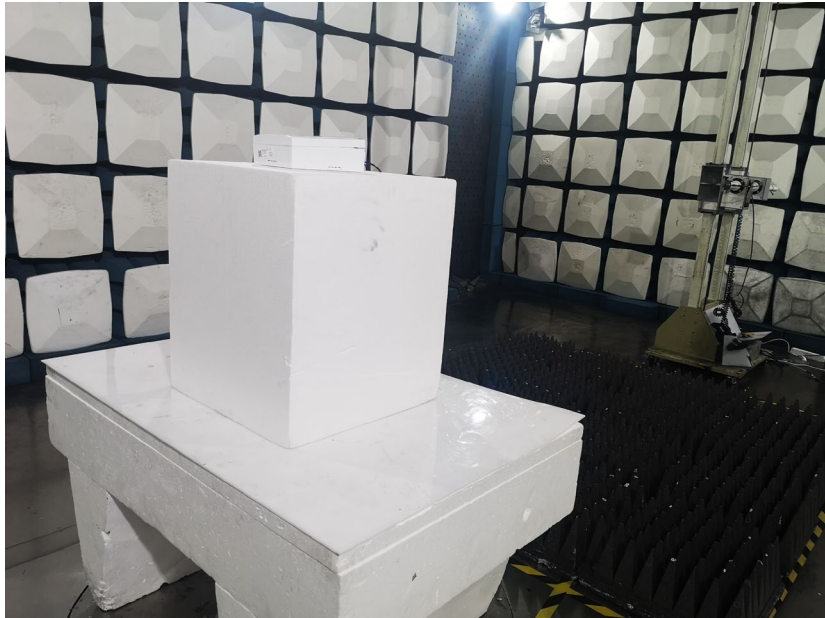

Above 1GHz

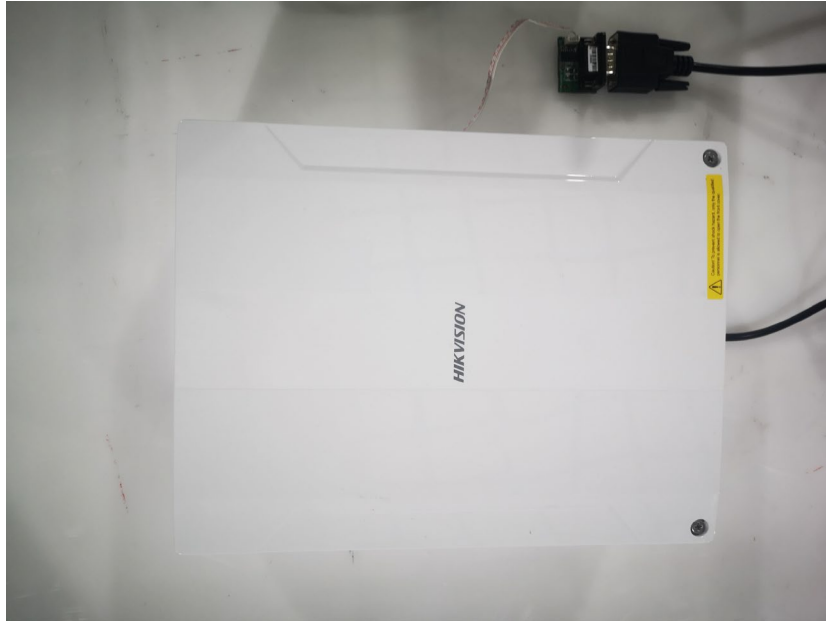
