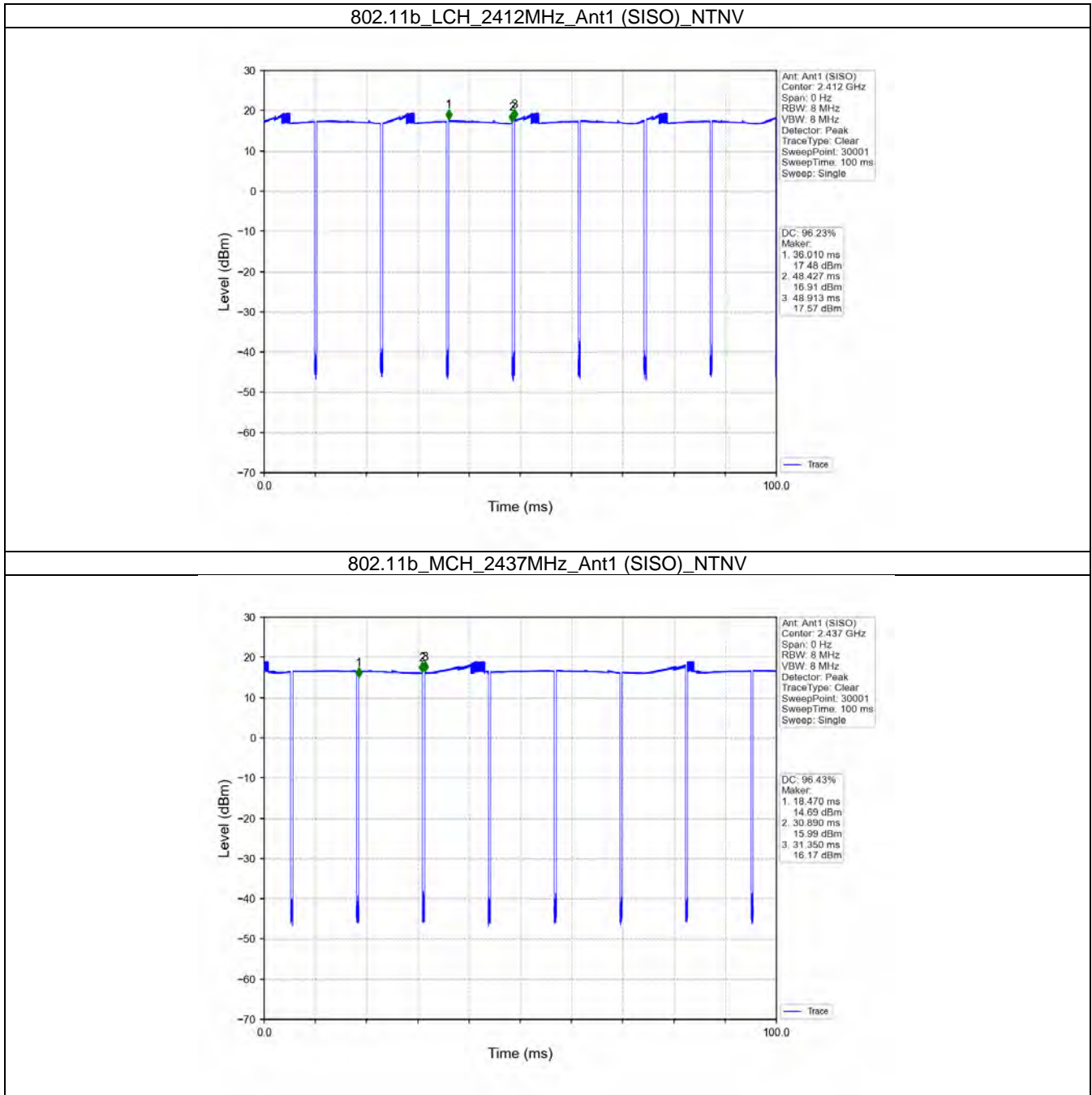

1.1.2 Test Graph



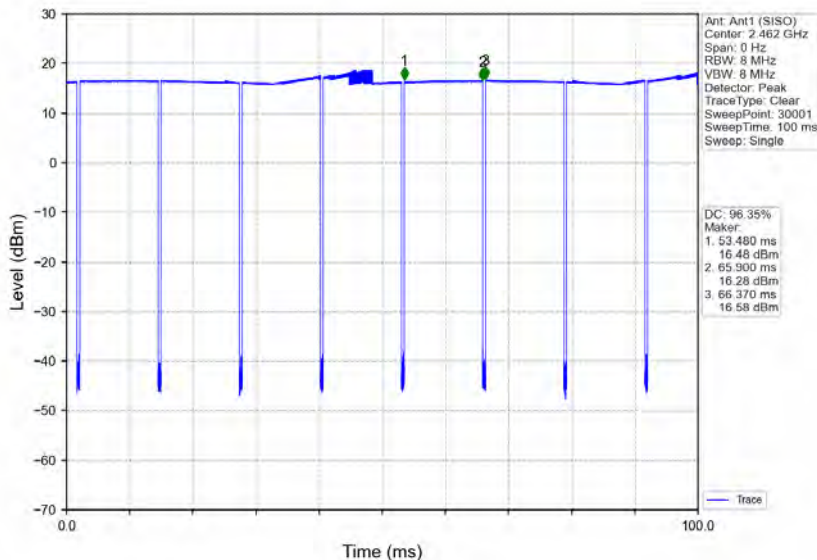

2.1.2 Test Graph

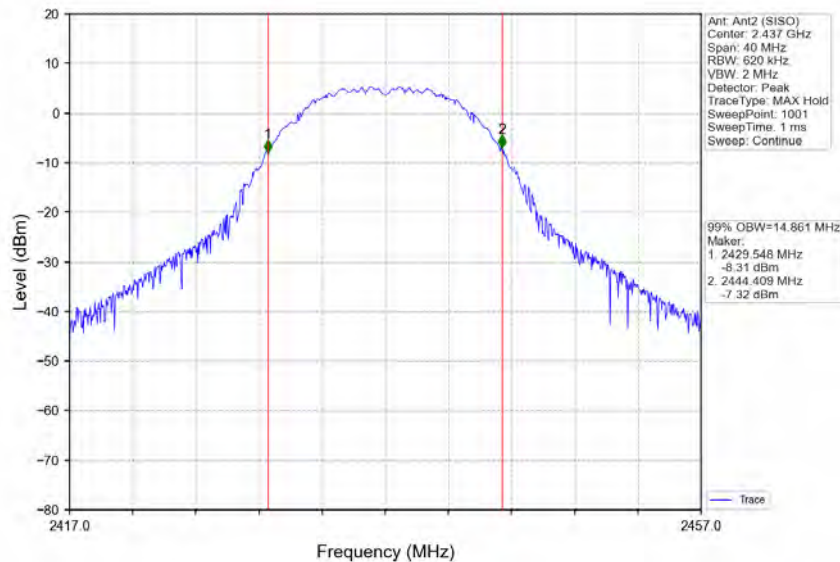

5.1.2 Test Graph



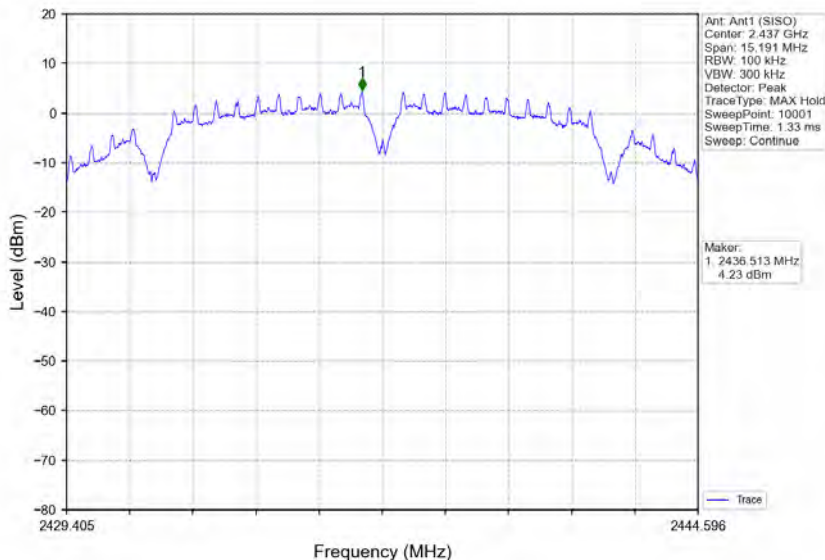
