5.2 MPE Calculation

The Max Conducted Peak Output Power is 70.47mW;

The best case gain of the antenna is 5.5dBi. 5.5dB logarithmic terms convert to numeric result is nearly 3.55; The two antennas completely correlated with each other, so the best case gain of the two antenna in MIMO mode is 8.50dBi, 8.50dB logarithmic terms convert to numeric result is nearly 7.08; *For FCC:*

According to the formula $S = \frac{PG}{4R^2\pi}$, we can calculate S which is MPE.

Note:

- 1) P (Watts)
- 2) G (Antenna gain in numeric)
- 3) R = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm²

For 2.4G WiFi

$$S = \frac{PG}{4R^2\pi} = \frac{70.47 \times 3.55}{4 \times 400 \times 3.14} = 0.050 \text{ mW/cm}^2 < 1 \text{mW/cm}^2$$

In MIMO mode:

$$S = \frac{PG}{4R^2\pi} = \frac{66.68 \times 7.08}{4 \times 400 \times 3.14} = 0.094 \text{ mW/cm}^2$$

So the device is exclusion from SAR test.
