

Description



- 2 Drill two screw holes according to the drill template if you use expansion screws.




3 Take out the adapter from the package. Align the screw holes and fix the adapter.

2 Adjust the surveillance angle.


- Rotate the camera body to adjust the panning position.

 Input the Wi-Fi password that your mobile phone has connected to, and tap Next to start the Wi-Fi connection process. (Locate the camera within 3 meters from the router when setting up the Wi-Fi.)
- Tap Add button in the next interface to finish adding.

- Check the memory card status by tapping on the Storage Status in the Device Settings interface.
- If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event-triggered video in the camera such as motion detection.

Playbac

Launch the Hik-Connect app, tap a connected device and tap Gallery button to play back.

Alarm Notification

Launch the Hik-Connect app and tap Message to see the alarm messages.
