5.2 MPE Calculation

For WiFi:

According to the formula $S=P/4\pi R^2$, we can calculate S which is MPE.

Note:

- 1) P (mW)
- 2) R = distance to the center of radiation of antenna (in meter) = 20cm
- 3) MPE limit = 1mW/cm²

The max. antenna gain is 2.8 dBi

For 13.56MHz: 59.62 dBuV/m=0.001 V/m < 60.77 V/m.

For 125kHz: 75.79 dBuV/m=0.006 V/m < 614 V/m

125kHz, 13.56MHz and WiFi modules can simultaneous transmitting, so the maximum rate of MPE is $0.001/60.77+0.01376/1.0+0.006/614=0.014\leq 1.0$. according to the KDB447498 section 7.2 determine the device is exclusion from SAR test.
