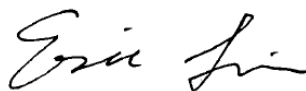

The BT or BLE, 2.4G Wi-Fi and 13.56MHz function can simultaneous transmitting. But the maximum rate of MPE is $0.00042/1.0+0.00716/1.0+0.20/60.77=0.011 \leq 1.0$. according to the KDB447498 section 7.2 determine the device is exclusion from SAR test.
