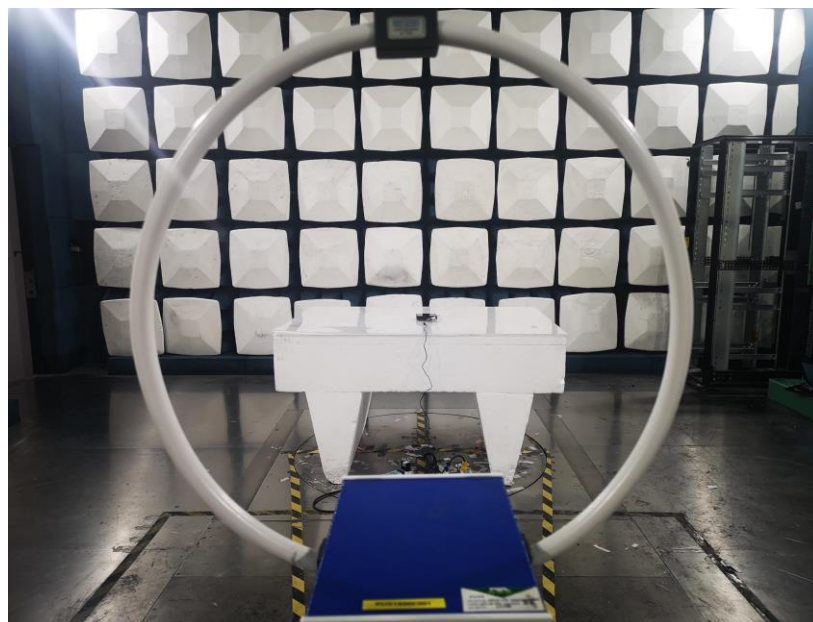
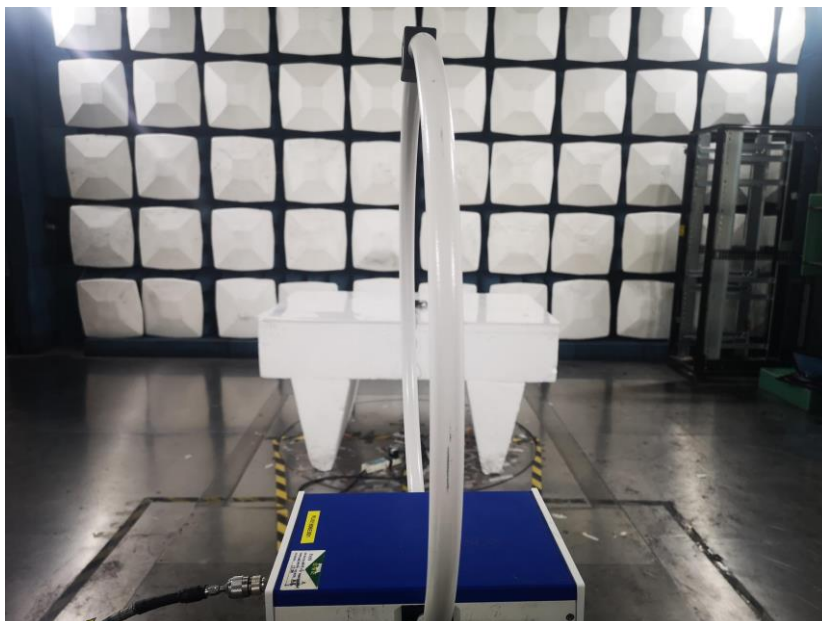

Below 30MHz

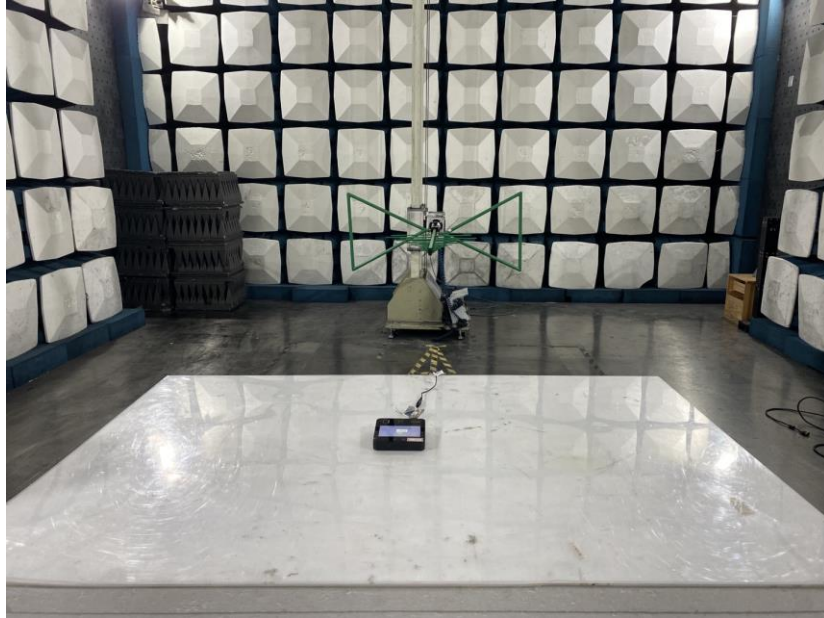

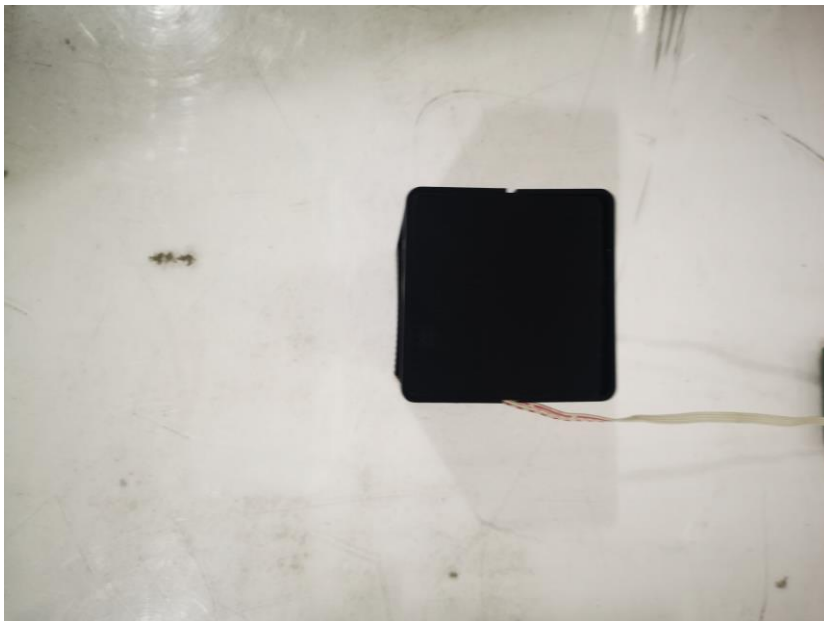
