

The 2.4G wifi and 13.56MHz function can simultaneous transmitting. But the maximum rate of MPE is  $0.00520/1.0+0.755/60.77 = 0.0176 < 1.0$ . according to the KDB447498 section 7.2 determine the device is exclusion from SAR test.
