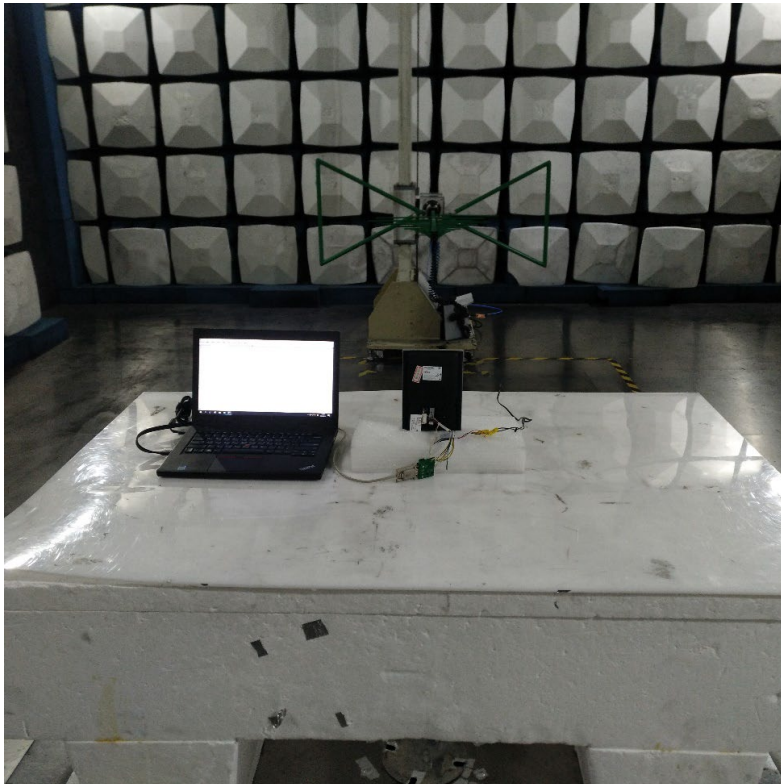

Radiated Spurious Emissions Below 1GHz

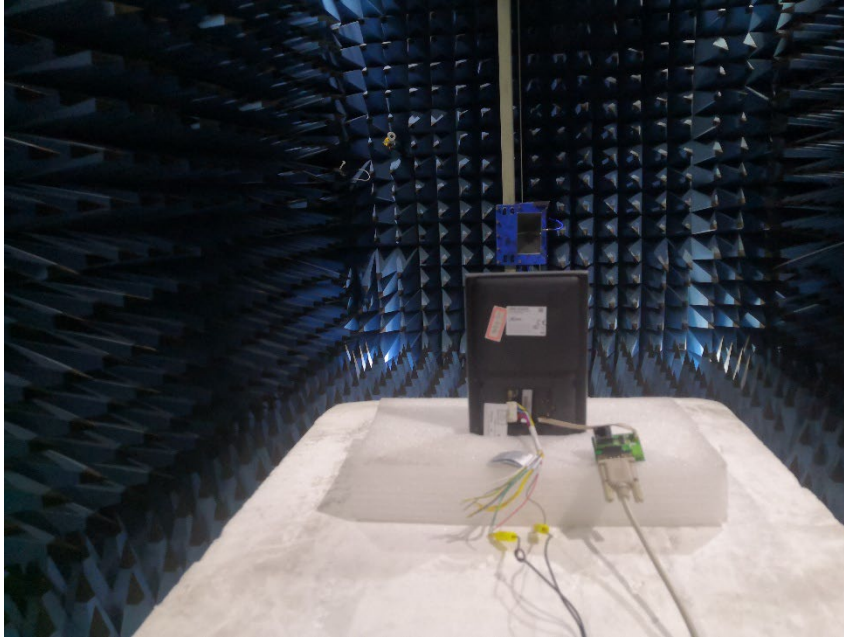

Radiated Spurious Emissions Above 1GHz

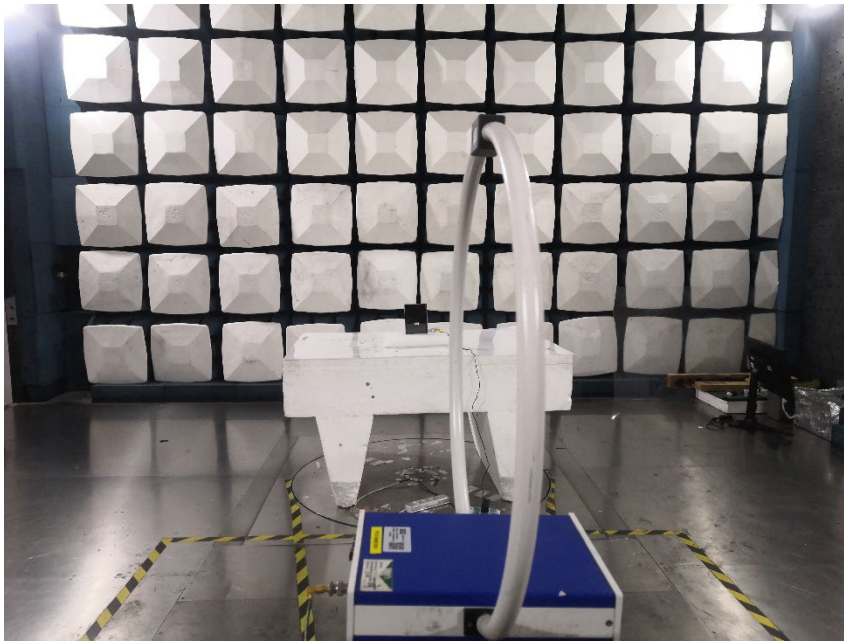
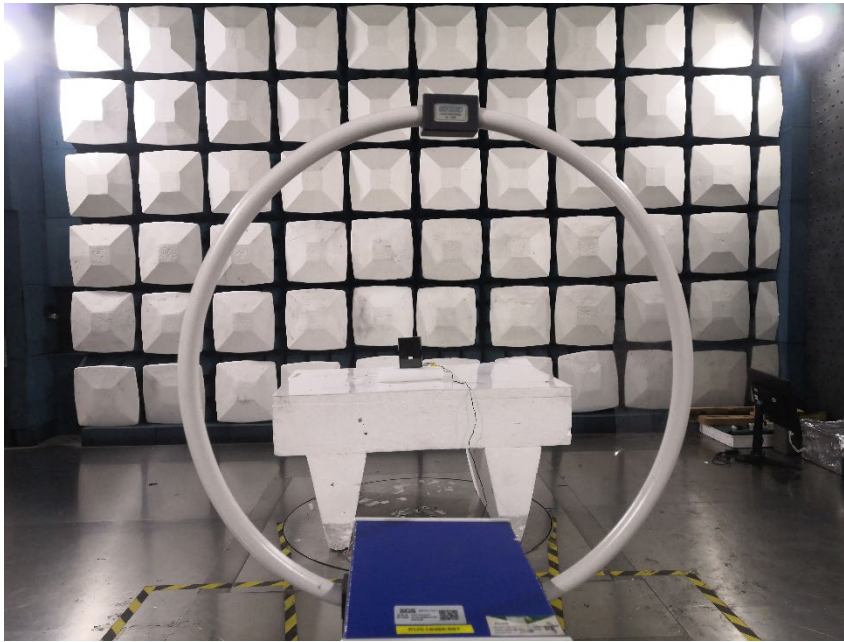


Conducted Emissions at AC Power Line
