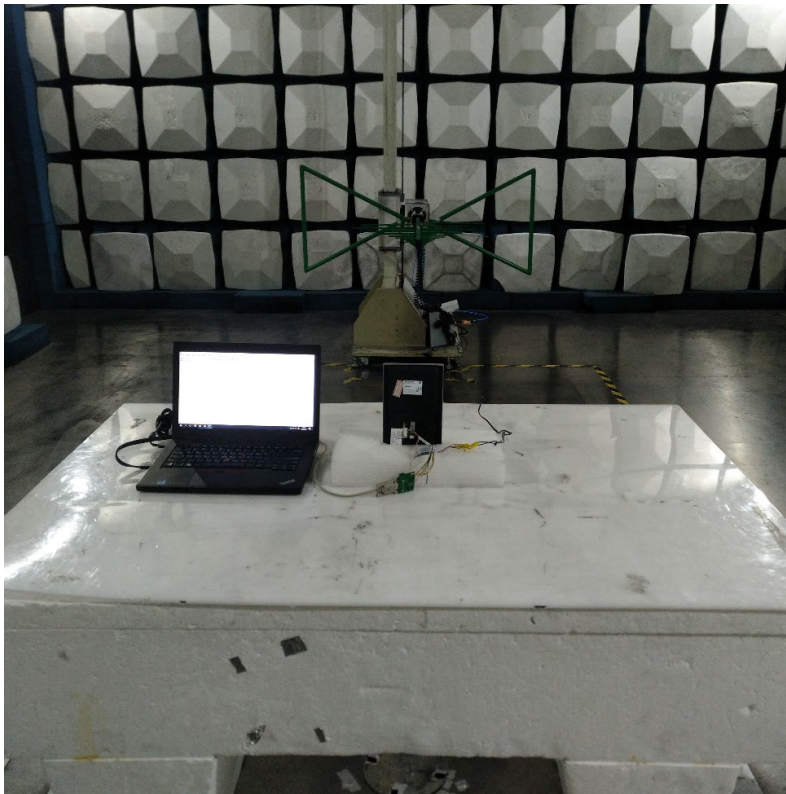

Radiated Spurious Emissions Below 1GHz

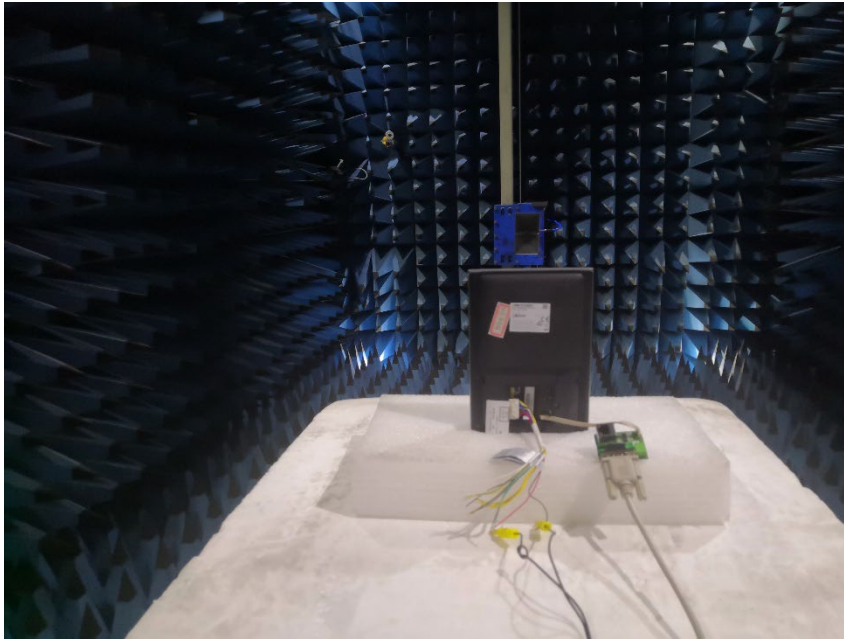

Conducted Emissions at AC Power Line

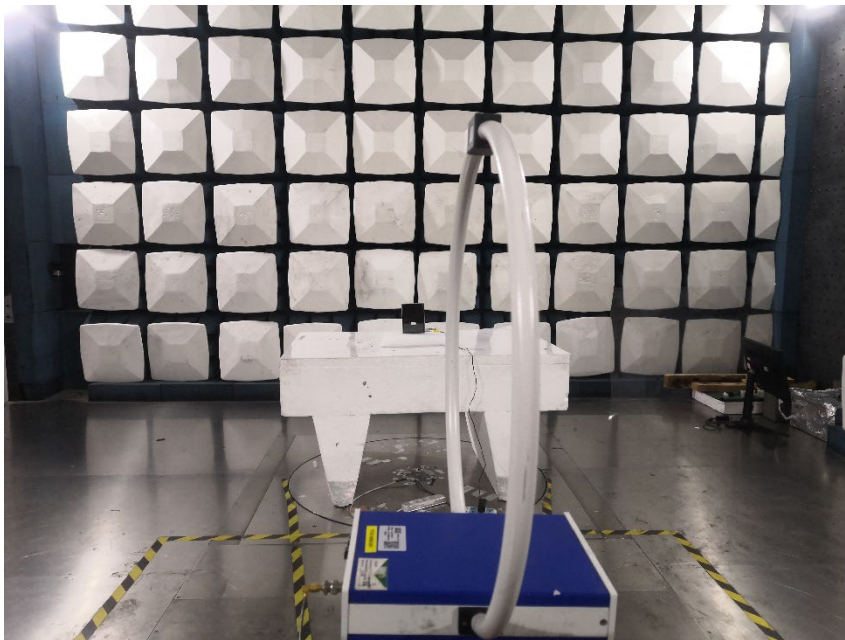
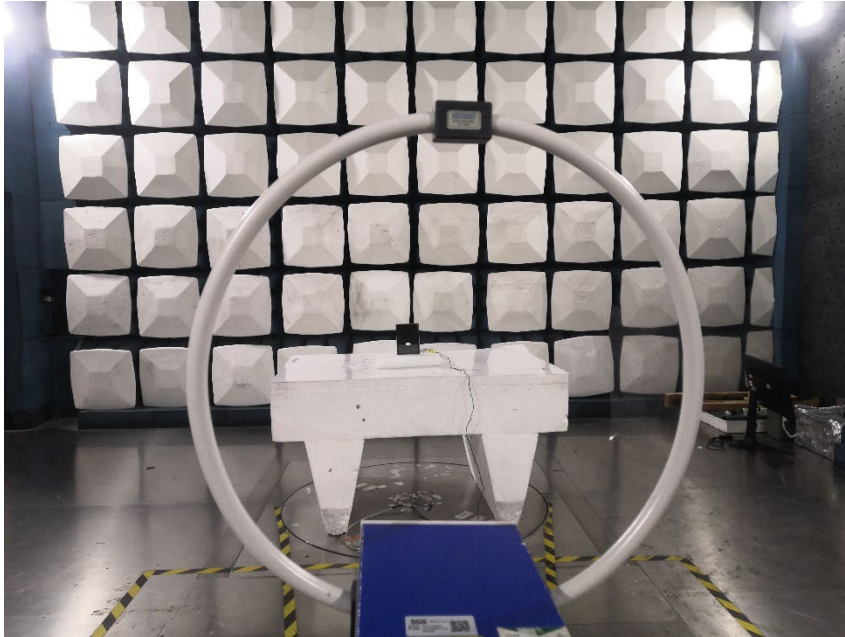
