## 2 Radiated Spurious Emissions Below 30MHz



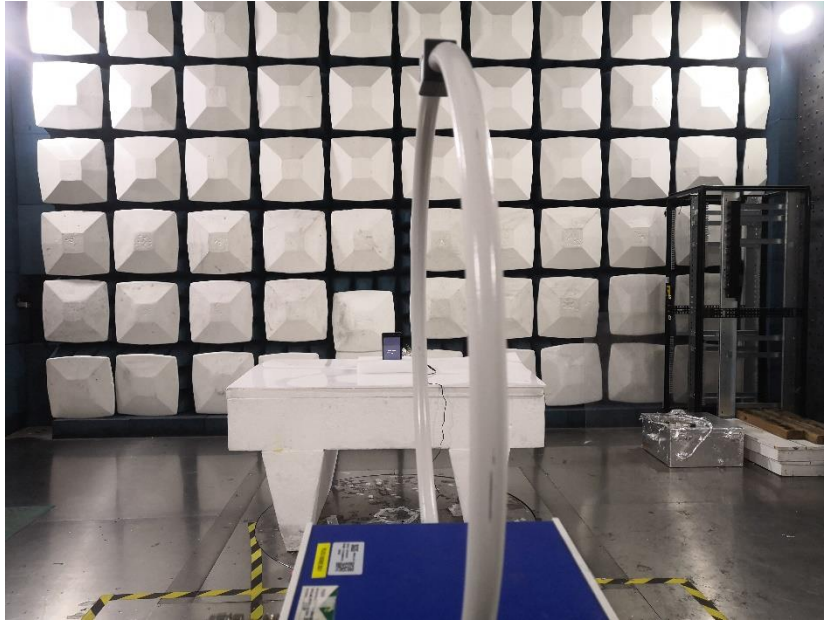

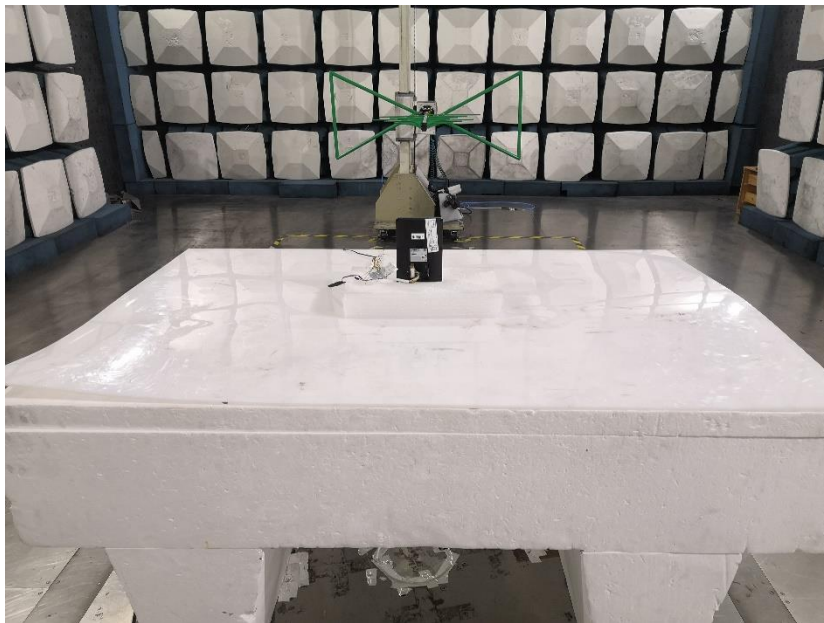

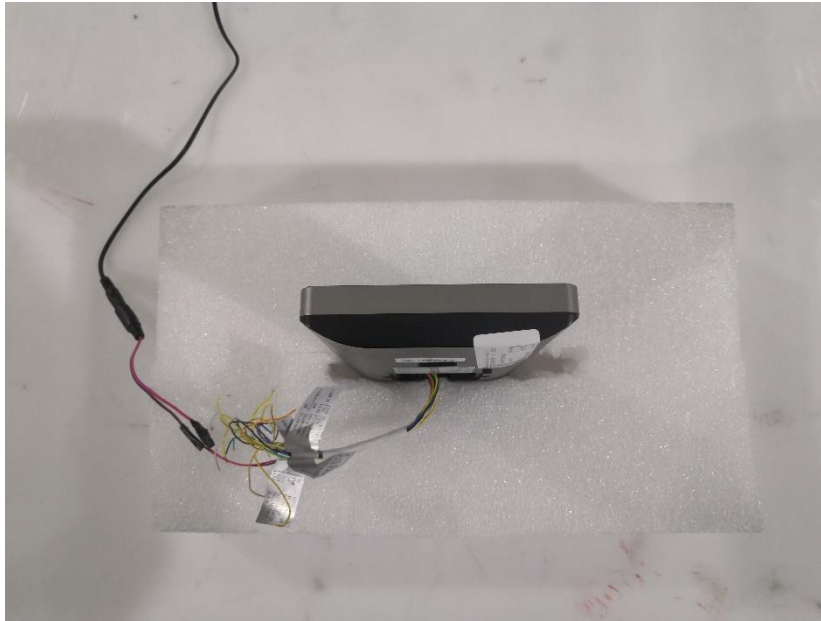
