5.2 MPE Calculation

The Max Conducted Average Output Power is 14.04dBm (25.35mW);

The best case gain of the antenna is 2dBi. 2dB logarithmic terms convert to numeric result is nearly 1.58

For FCC:

According to the formula $S = \frac{PG}{4R^2\pi}$, we can calculate S which is MPE.

Note:

1) P (Watts) = Power Input to antenna = $10^{\frac{dBm}{10}} / 1000$

2) G (Antenna gain in numeric) = $10^{(Antenna\ gain\ in\ dBi / 10)}$

3) R = distance to the center of radiation of antenna (in meter) = 20cm

4) MPE limit = 1mW/cm²

For WiFi: $S = \frac{PG}{4R^2\pi} = \frac{25.35 \times 1.58}{4 \times 400 \times 3.14} = 0.008\ mW/cm^2$

For 13.56MHz: 67.46dBuV/m = 0.002 V/m < 60.77 V/m.

13.56MHz and WiFi modules can simultaneous transmitting, so the maximum rate of MPE is $\frac{0.002}{60.77} + \frac{0.008}{1} = 0.008 \leq 1.0$. according to the KDB447498 section 7.2 determine the device is exclusion from SAR test.
