


For WiFi:

According to the formula  $S=P/4\pi R^2$ , we can calculate S which is MPE.

Note:

- 1) P (mW)
- 2) R = distance to the center of radiation of antenna (in meter) = 20cm
- 3) MPE limit = 1mW/cm<sup>2</sup>

The 2.4G band and 13.56MHz function can simultaneous transmitting. But the maximum rate of MPE is  $0.011/1.0+1.45/60.77=0.035\leq 1.0$ . So the device is exclusion from SAR test.
