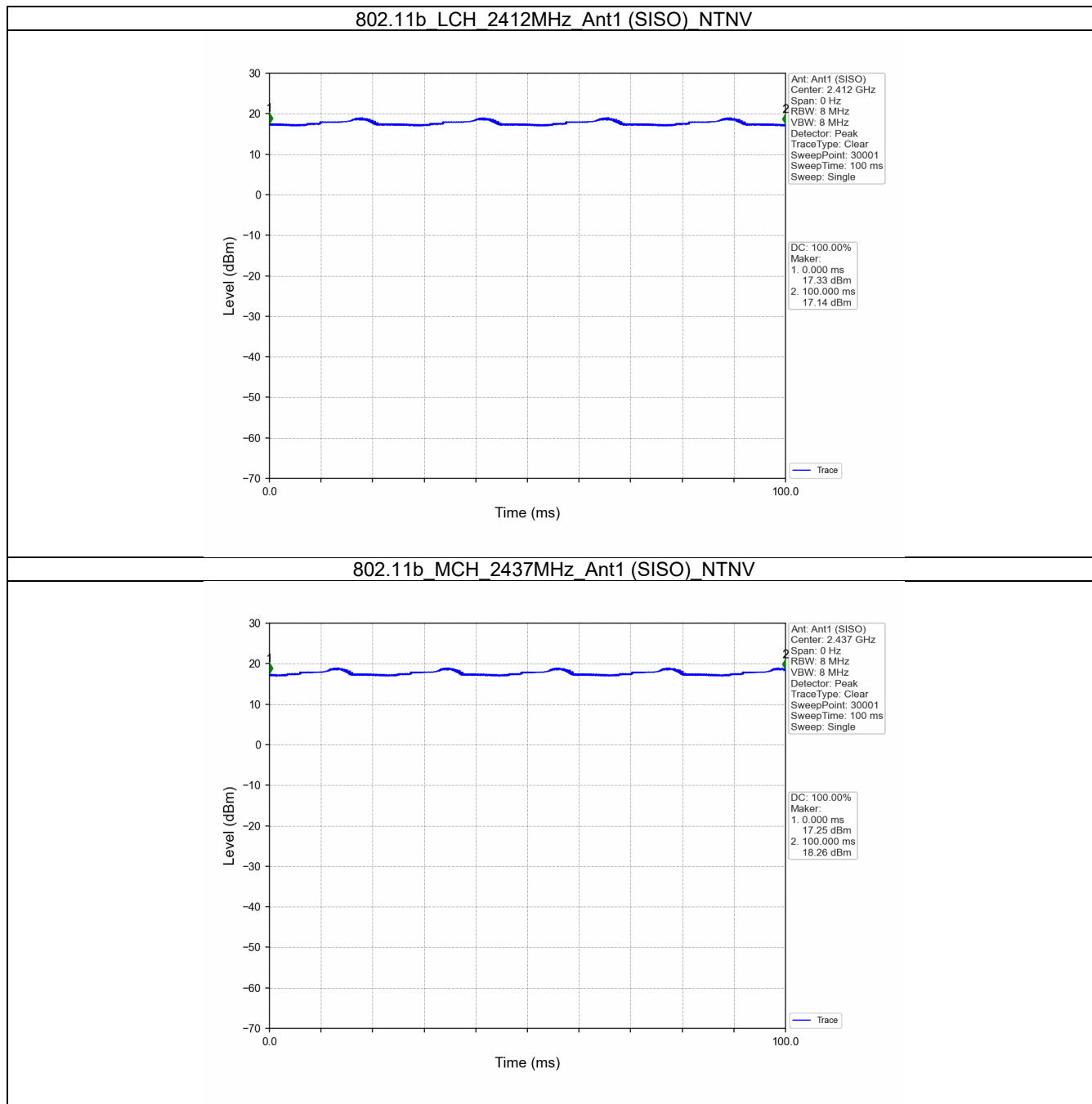

1.1.2 Test Graph



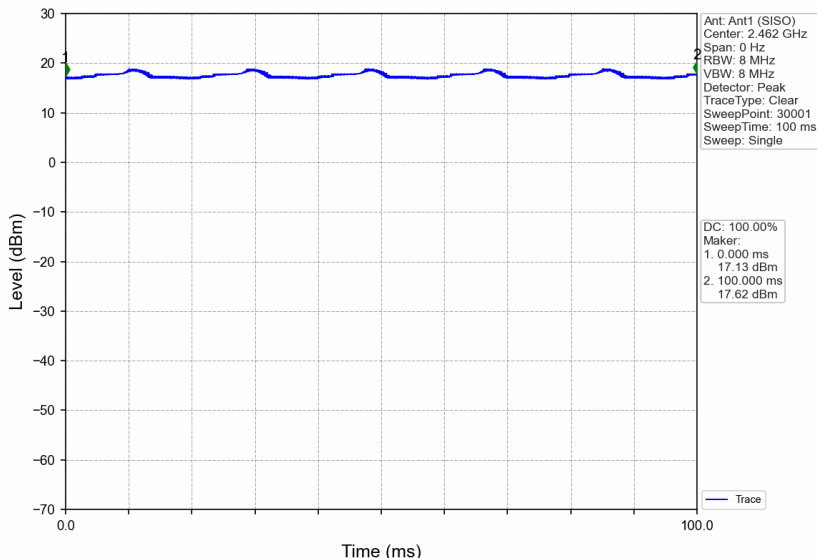

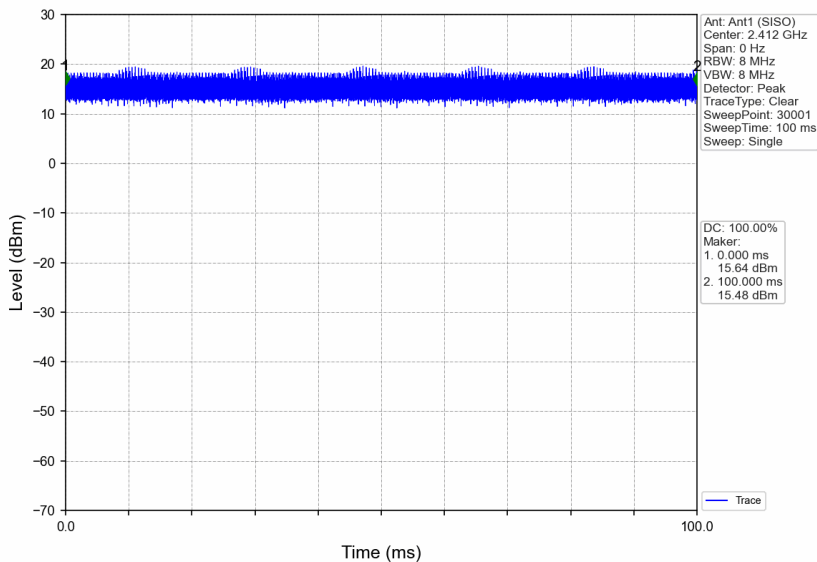

802.11b HCH 2462MHz Ant1 (SISO) NTV

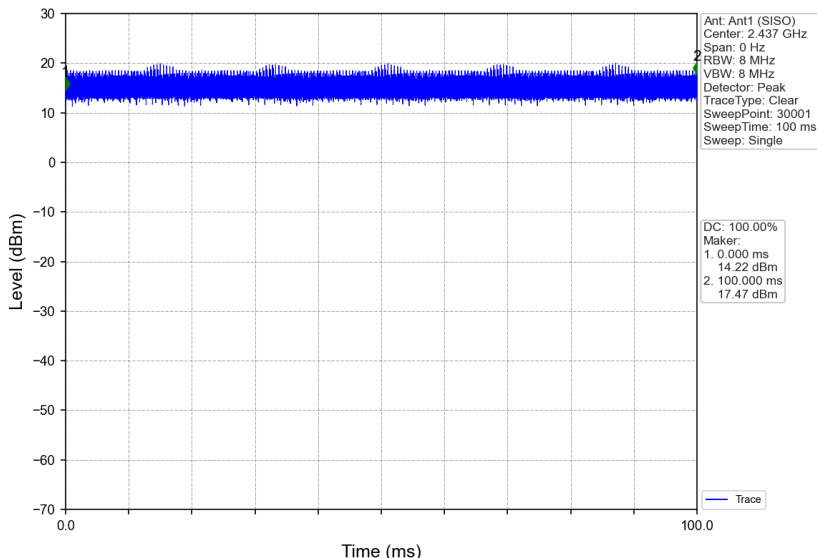

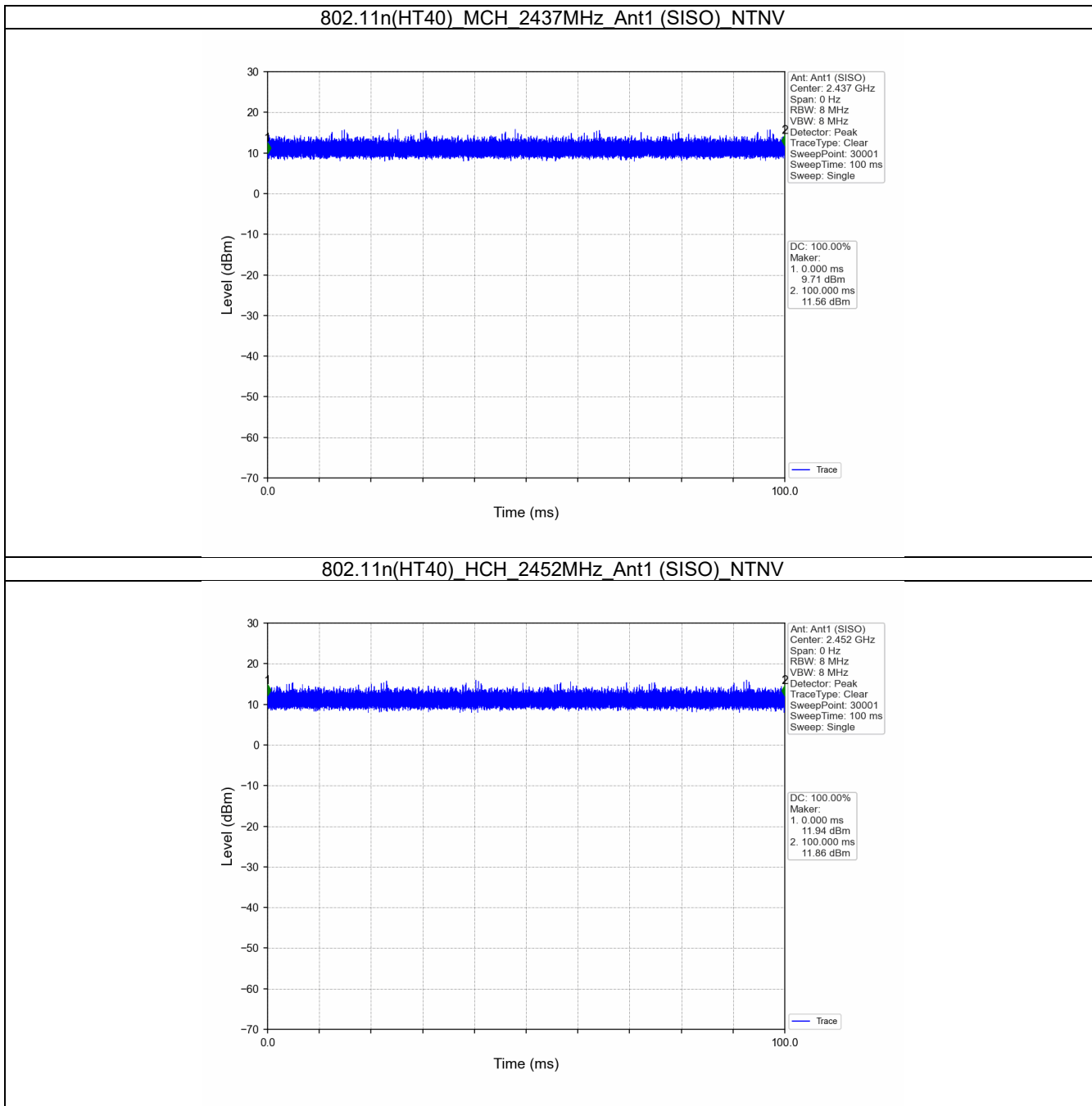
802.11n(HT20) HCH 2462MHz Ant1 (SISO) NTV
