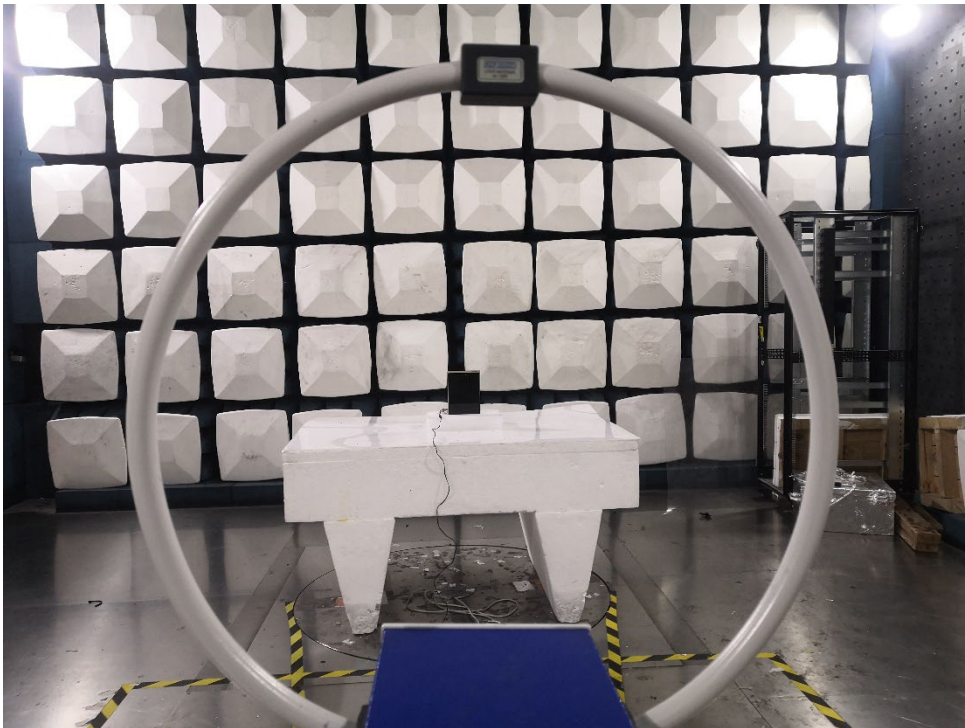

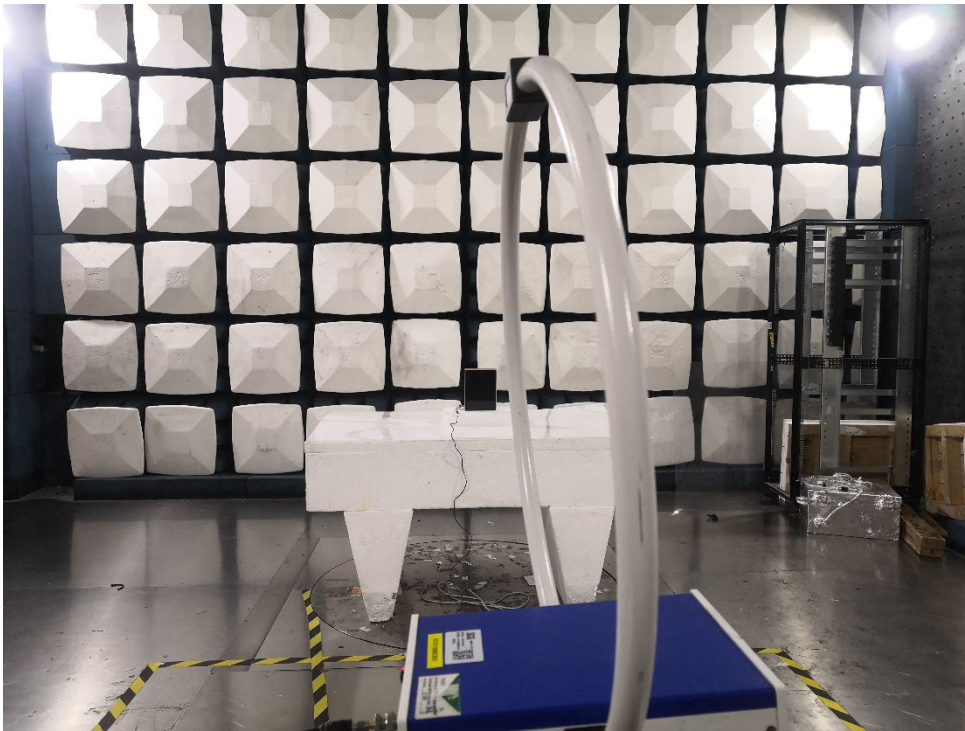

**3 Radiated Spurious Emissions From 30MHz to 1GHz**



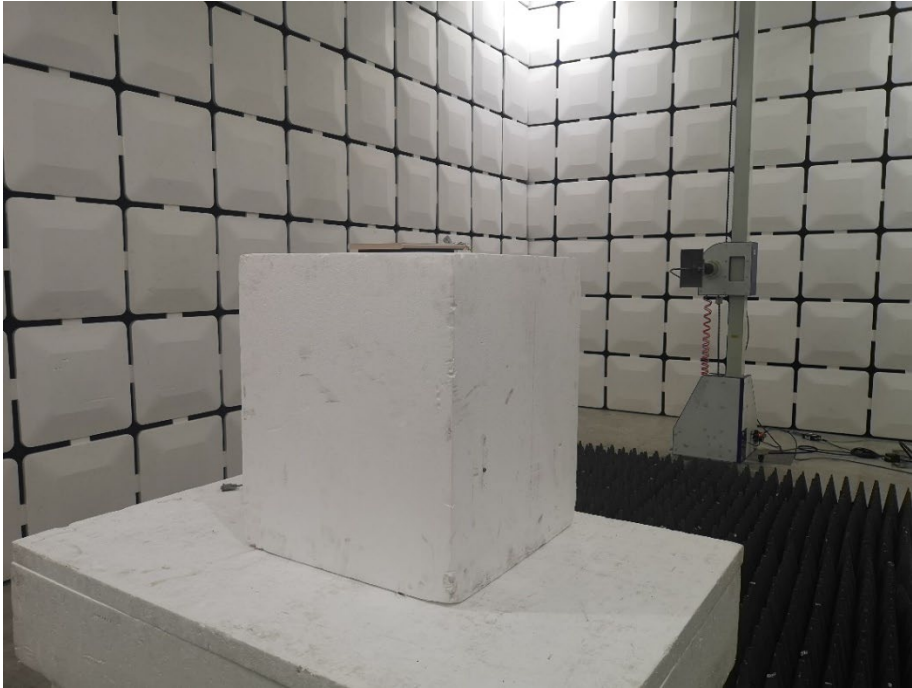

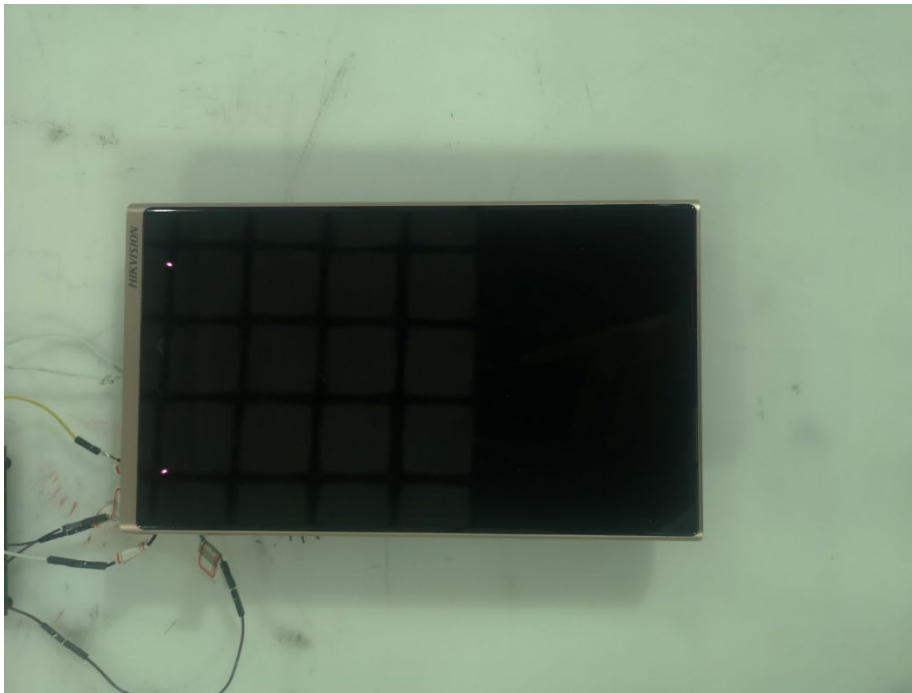
