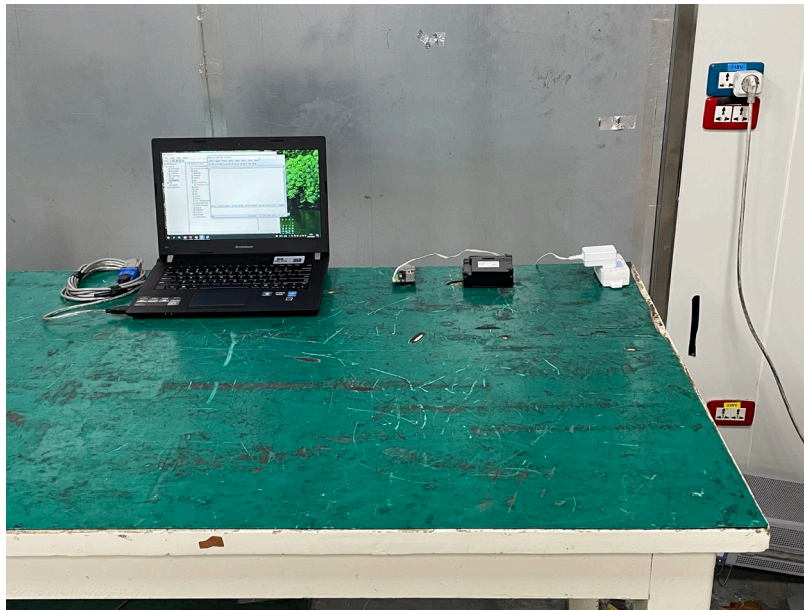

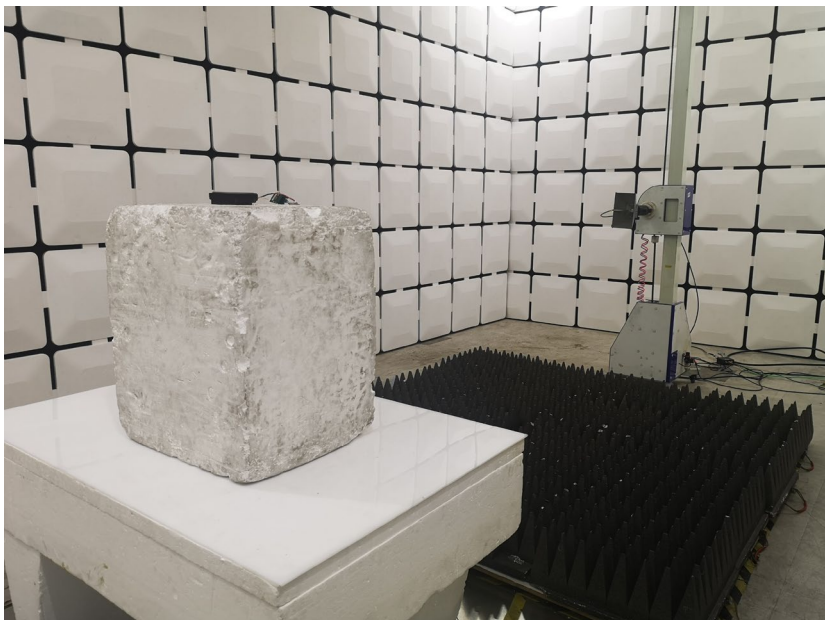

Above 1GHz



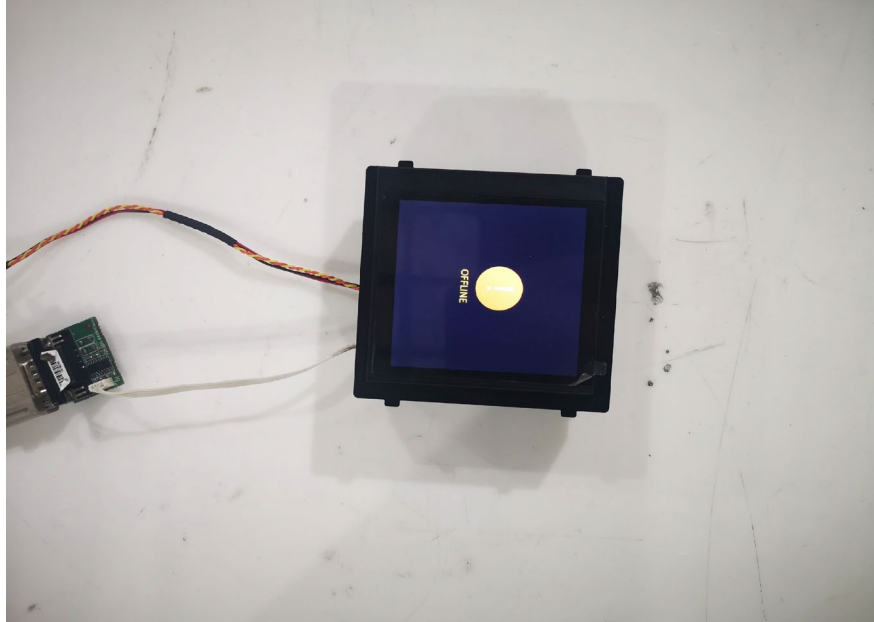
