


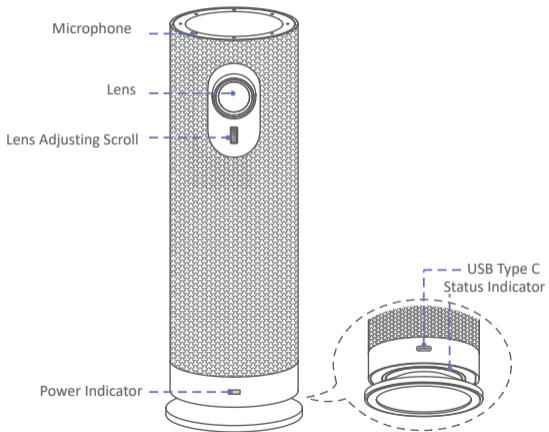
Quick Start Guide



## Functions



	<p>Pan/tilt the camera. Press the button to adjust the camera by level. Press and hold the button to adjust the camera continuously.</p>
	<p>Turn on/off video streaming.</p>
	<p>Press the button to zoom in/out by level. Press and hold the button to adjust the camera continuously.</p>
	<p>Turn on/off the pickup function of the camera.</p>
	<p>Adjust the volume of speaker. Press the button to adjust the volume by level. Press and hold the button to adjust the volume continuously.</p>
	<p>Scroll the file page.</p>
	<p>Double-click to enter the hyperlink. Click one time to switch the hyperlink.</p>
	<p>Restore to the default settings. Press and hold the two buttons at the same time for 5 seconds, and the indicator of the device flashes red three times. Restart the device and it returns to the default settings.</p>

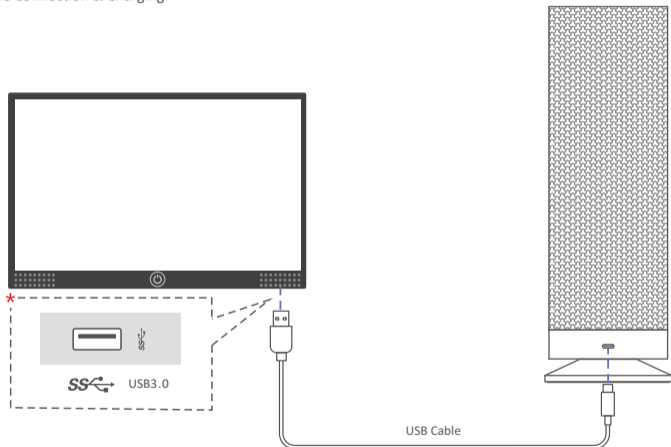

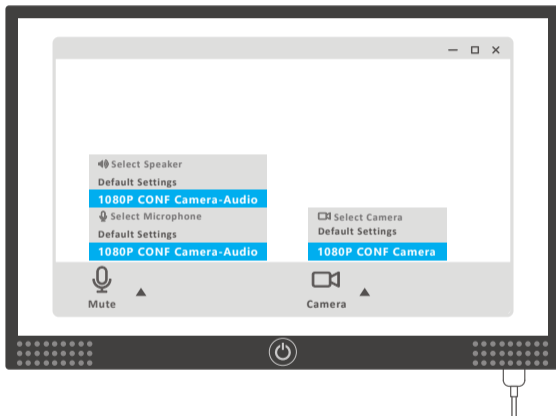
- USB Cable Connection & Charging

## Setup Guide



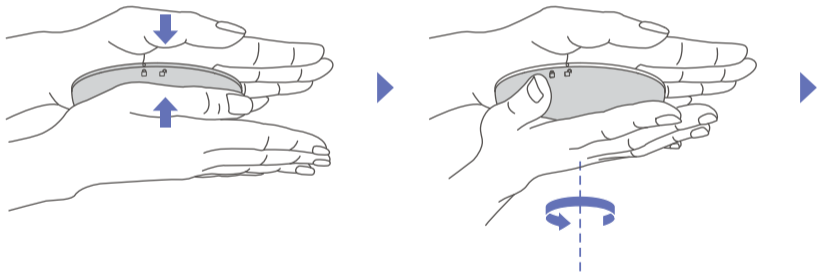
- \* Power on the device and open the conference/video software. Select the speaker and microphone as 1080P CONF Camera-Audio, and select the Camera as 1080P CONF Camera. Take the actual product name as standard.



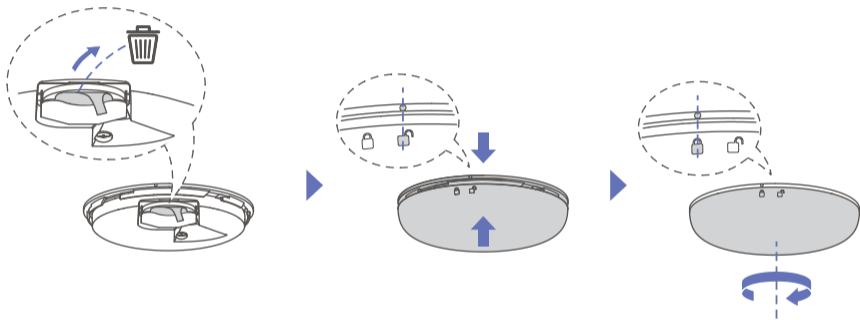


## Using Guide

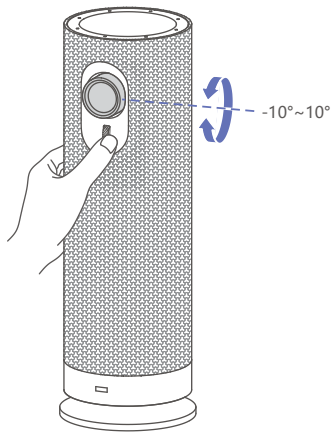
- Open the battery cover and remove the battery pull tab before using.



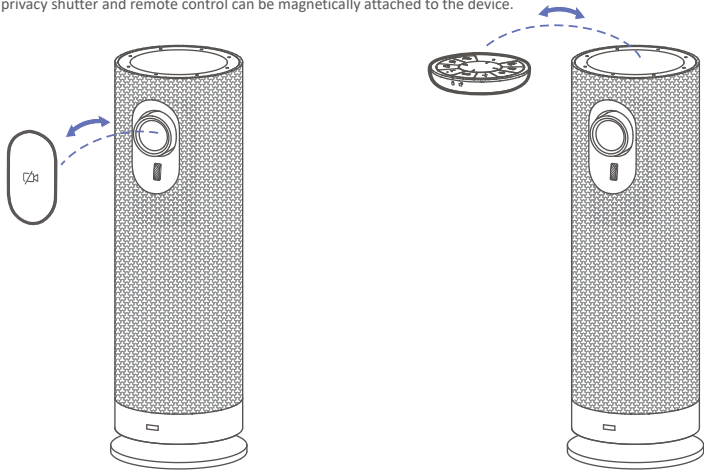
- \* Press the remote control with both hands and rotate it in the direction of arrow to open the battery cover.

### Warnings

#### Laws and Regulations
