#### 4 Test Standards and Limits

#### 4.1 FCC Radiofrequency radiation exposure limits

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

[(max power of channel)/(min test separation distance)]\*[ $\sqrt{f(GHz)}$ ]  $\leq 3.0$  for 1-g SAR and  $\leq 7.5$  for 10-g extremity SAR, where

- f(GHz) is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm
- The result is rounded to one decimal place for comparison
- 3.0 and 7.5 are referred to as the numeric thresholds

The test exclusions are applicable only when the minimum test separation distance is  $\leq$  50 mm, and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm according to 4.1 f) is applied to determine SAR test exclusion.

Output power level shall be the higher of the maximum conducted or equivalent isotropically radiated power (e.i.r.p.) source-based, time-averaged output power. For controlled use devices where the 8 W/kg for 1 gram of tissue applies, the exemption limits for routine evaluation are multiplied by a factor of 5. For limb-worn devices where the 10 gram value applies, the exemption limits for routine evaluation in Table 1 are multiplied by a factor of 2.5. If the operating frequency of the device is between two frequencies located in Table 1, linear interpolation shall be applied for the applicable separation distance. #### 6.2 RF Exposure Calculation

The Max Conducted Peak Output Power is 0.67 mW. The best case gain of the antenna is -0.12dBi.

Max Conducted Peak Output Power = 0.67mW <10mW <23.81mW

**Remark**: we used the maximum power between the conducted power and ERP/EIRP to perform RF exposure exemption evaluation.

So the SAR report is not required.
