Objective





- 2) For test separation distances \leq 50 mm, the power threshold determined by the equation in c) 1) for 50 mm and 100 MHz is multiplied by $\frac{1}{2}$
- 3) SAR measurement procedures are not established below 100 MHz.

The SAR Exclusion Threshold Level for 13.56MHz when the minimum test separation distances \leq 50 mm:

The maximum tune-up power = -29 dBm = 0.001 mW, which less than 443 mW @ 13.56 MHz Exclusion Threshold Level.

So the stand-alone SAR evaluation can be exempted.



The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.


