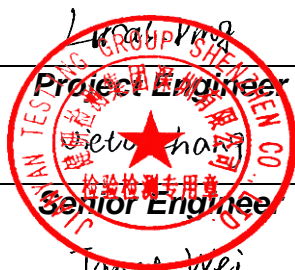

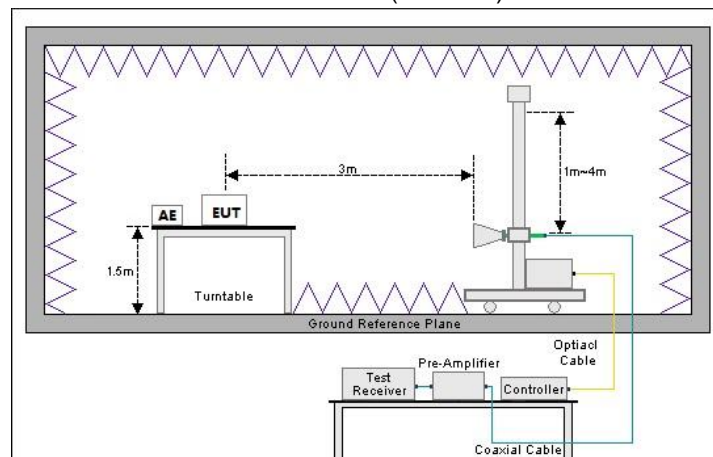

Differences: Add bands 13 and 26 by modifying software and changing component suppliers for U3220, U3204, U3228, so need to retest radiated emission and spot-check radiated output power.
