
Test Procedure

For n77/n78:

Following procedure can be done by applying WINNF-TS-0122-V1.0.2 CBRS CBSD Test Specification, use the certified base station CBSD(FCC ID: 2AG32BSC7048A243) as companion device to show compliance with Part 96.47 requirement for End user device (EUD):

- a) Setup with frequency 3600MHz and power level 2.45dBm/MHz;
- b) Enable CBSD service with n77;
- c) Check EUD Tx Frequency and power;
- d) Disable CBSD service;
- e) Check EUD stops transmission within 10 seconds;
- f) Setup with frequency 3675MHz and power level 14.71dBm/MHz;
- g) Enable CBSD service with n78;
- h) Check EUD Tx Frequency and power;
- i) Disable CBSD service;
- j) Check EUD stops transmission within 10 seconds;






3600MHz-Stop operation in 10s


