

Emission Mask D — 12.5 kHz channel bandwidth equipment

For transmitters designed to operate with a 12.5 kHz channel bandwidth, any emission must be attenuated below the power (P) of the highest emission contained within the authorized bandwidth as follows:

- (1) On any frequency from the centre of the authorized bandwidth f_0 to 5.625 kHz removed from f_0 : 0dB


