Per the labelling KDB, it is ok to have the labelling in an accessible area such as the battery compartment as long as the label is viewable at the time of purchase.

From the product photo, you may find the battery compartment is the back of PCB and on the most part of the middle is some metal for power supply. I think it is hard to label on. Please confirm this product need not label as it is too small. Thank you.
