


1. DOWNLOAD THE MOBILE APP



2. INSTALL VIA MOBILE APP




3. SET YOUR SMART SCHEDULE



Go to the Smart Schedule and configure it to meet your needs.




Choose your AC settings for when you are home.

IMPORTANT

The tado° Smart AC Control needs direct visual contact to your air conditioner just like your remote control. Please make sure that you do not block the tado° when interacting with it.



ACTIVATE AND SKIP BETWEEN MENU PAGES



Touch the front of the device to activate the display and skip between the individual settings pages.


QUICKLY TURN AC POWER ON OR OFF


Room Overview

MOBILE APP – CONTROL PANEL

Open the control panel by pressing the AC settings on the main screen.

Change Settings


Here you can change the AC settings for your current mode. Your options may look different depending on your AC.

Timer

Set a timer to keep the setting changes for a fixed time frame.

Manual

The settings will be kept until you reset it. Presence detection and time blocks will be ignored.



MOBILE APP – AUTOMATIC MODES

Each mode can have its own AC settings.

Home Modes


As long as somebody is home then these modes are active – which depends on the scheduled time blocks.

Sleep Modes


These modes control the AC operation at night when somebody is home. Choose if the AC should be running or off, or set different modes for different times of the night.

Away Mode

Becomes active as soon as everybody has left home. Decide on the AC settings for this mode.



MOBILE APP – SMART SCHEDULE



Create schedules for each individual weekday or one for all weekdays.

Timeblock

Assign a mode with its specific AC settings to each time block. These blocks only become active if somebody is detected at home.

YOUR RIGHTS AND THIS LIMITED WARRANTY

This Limited Warranty gives you specific legal rights. You may also have other legal rights that vary by state, province or jurisdiction. The disclaimers, exclusions, and limitations of liability under this Limited Warranty will not apply to the extent prohibited by applicable law. 1. WHAT THIS LIMITED WARRANTY COVERS; PERIOD OF COVERAGE

tado GmbH ("tado°"), Lindwurmstr. 76, 80337 Munich, Germany, warrants to the owner of the enclosed product that the product contained in this box ("Product") will be free from defects in materials and workmanship for a period of two (2) years (or one (1) year for Factory Refurbished Products) from the date of delivery following the original retail purchase (the "Warranty Period"). If the Product fails to conform to this Limited Warranty during the Warranty Period, tado° will, at its sole discretion, either (a) repair or replace any defective Product or component; or (b) accept the return of the Product and refund the money actually paid by the original purchaser for the Product. Repair or replacement may be made with a new or refurbished product or components, at tado°'s sole discretion. If the Product or a component incorporated within it is no longer available, tado° may replace the Product with a similar product of similar function, at tado°'s sole discretion. This is your sole and exclusive remedy for breach of this Limited Warranty. Any Product that has either been repaired or replaced under this Limited Warranty will be covered by the terms of this Limited Warranty for the longer of ninety (90) days from the date of delivery or the remaining Warranty Period. This Limited Warranty is transferable from the original purchaser to subsequent owners, but the Warranty Period will not be extended in duration or expanded in coverage for any such transfer.

2. TOTAL SATISFACTION RETURN POLICY

If you are the original purchaser of the Product and you are not satisfied with this Product for any reason, you may return it in its original condition within thirty (30) days of the original purchase and receive a full refund.

3. WARRANTY CONDITIONS; HOW TO GET SERVICE IF YOU WANT TO CLAIM UNDER THIS LIMITED WARRANTY

Before being able to claim under this Limited Warranty, the owner of the Product must (a) notify tado° of the intention to claim by visiting tado.com/support during the Warranty Period and providing a description of the alleged failure, and (b) comply with tado°'s return shipping instructions. tado° will have no warranty obligations with respect to a returned Product if it determines, in its reasonable discretion after examination of the returned Product, that the Product is an Ineligible Product (defined below). tado° will bear all costs of return shipping to owner and will reimburse any shipping costs incurred by the owner, except with respect to any Ineligible Product, for which owner will bear all shipping costs.
