User Guide

FZB57A3+ module belongs to TI module that usually used in gateway's development. A shielding case on it is to insulate from external signals. It has an IPEX antenna to connection external antenna, which is used to enhance the sending and receiving signals of the module; FZB57A3+ module, a total of 20 pin ,as for gateway development, only eight of pin are used, function of other pin for the developers. In addition, module also retained the DEBUG interface and UART interface.
