Data Traffic Plot

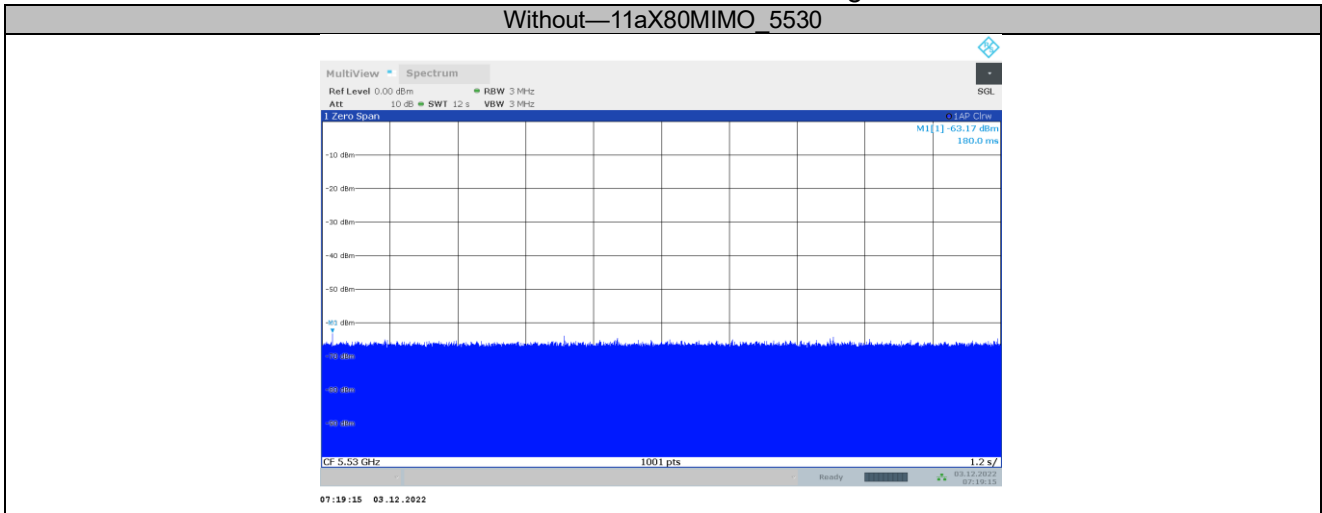
