Test Graphs of Spurious Emissions outside of the 5.470-5.725 GHz band for transmitters operating in the 5.470-5.725 GHz band

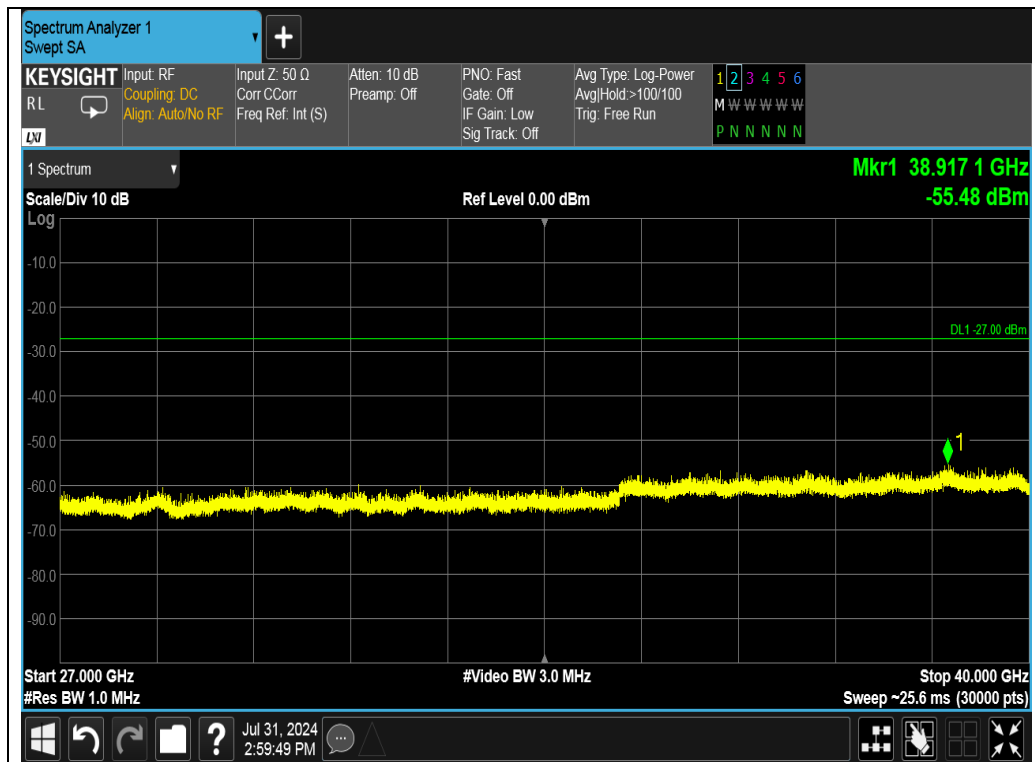
