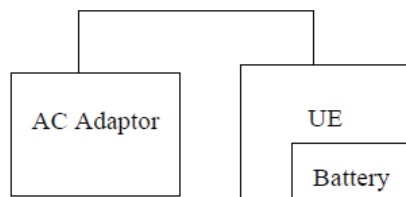
7.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

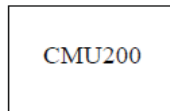
7.2 EUT Exercise

7.4 Description of Test modes

During all testing, EUT is in link mode with base station emulator at maximum power level. The spurious emission measurements were carried out in semi-anechoic chamber with 3-meter test range, and EUT is rotated on three test planes to find out the worst emission.

Frequency range investigated for radiated emission is as follows:

30 MHz to 10000 MHz for CDMA2000 BC0.

30 MHz to 20000 MHz for CDMA2000 BC1.






Test Procedure:	<ol style="list-style-type: none"> 1. The EUT was placed on a non-conductive turntable using a non-conductive support. The radiated emission at the fundamental frequency was measured at 3 m with a test antenna and EMI spectrum analyzer. 2. During the measurement, the EUT was in communication with the station. The highest emission was recorded with the rotation of the turntable and the lowering of the test antenna from 4m to 1m. The reading was recorded and the field strength (E in dBuV/m) was calculated. 3. ERP in frequency band 824.2 –848.80.8MHz were measured using a substitution method. The EUT was replaced by a dipole antenna connected, the S.G. output was recorded and ERP was calculated as follows: $\text{ERP} = \text{S.G. output (dBm)} + \text{Antenna Gain (dBd)} - \text{Cable Loss (dB)}$ 4. EIRP in frequency band 1850.2 –1909.8MHz were measured using a substitution method. The EUT was replaced by a horn antenna connected, the S.G. output was recorded and EIRP was calculated as follows: $\text{EIRP} = \text{S.G. output (dBm)} + \text{Antenna Gain (dBi)} - \text{Cable Loss (dB)}$

Test Procedure:	<ol style="list-style-type: none"> 1. The EUT was placed on a non-conductive turntable using a non-conductive support. The radiated emission at the fundamental frequency was measured at 3 m with a test antenna and EMI spectrum analyzer. 2. During the tests, the antenna height and the EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. This maximization process was repeated with the EUT positioned in each of its three orthogonal orientations. 3. The frequency range up to tenth harmonic was investigated for each of three fundamental frequency (low, middle and high channels). Once spurious emission was identified, the power of the emission was determined using the substitution method. 4. The spurious emissions attenuation was calculated as the difference between radiated power at the fundamental frequency and the spurious emissions frequency. $\text{ERP / EIRP} = \text{S.G. output (dBm)} + \text{Antenna Gain(dB/dBi)} - \text{Cable Loss (dB)}$
